Earthquake & Fire Mock Drill conducted at Directorate of Tribal Welfare

The exercise commenced with a Table Top Discussion, where officials finalized the drill scenario and assigned roles and responsibilities to Department personnel and emergency response teams. The mock drill began at 11.10 am, during which, staff followed the 'Duck, Cover & Hold' technique for earthquake safety before evacuating to designated safe zones. Fire alarms were sounded and communication was established with SEOC (1070), DEOC (S/A) (1077), ERSS (112), and relevant Resource Departments. Search and rescue teams conducted operations for missing individuals, while first aid was administered to the injured. The Fire Tender and ambulance arrived promptly, and the drill concluded with an 'All Clear' message from the Incident Commander. Later, a debriefing session was held, where officials from Disaster Management, District Administration, A&N Police, Fire and Health Departments commended the successful execution of the drill. They also emphasized the importance of regular training sessions to enhance disaster preparedness among staff, a press release from Directorate of Disaster Management said.
