

Diglipur Police solves sensational murder case...

condition at around 10.45 pm on 29/03/2025, near the place where the deceased was last seen. The vehicle was traced back to one S. Gangaya, S/ o Salapathi, R/o R.K. Gram, Diglipur. He and his labourers were summoned to the Police Station Diglipur for verification of facts. Initially, he tried to mislead the Police team but subsequently confessed that he along with his associates had murdered the missing Reporter Sahdev Dey.

Upon this, an FIR No. 24/2025 dated 01/04/2025 U/S 103(1)/61(2)/238 BNS, 2023 was registered in PS Diglipur. Considering the seriousness of the case, a special investigation team was also constituted under the supervision of Shri Ankesh Yadav, SDPO Diglipur, assisted by Inspr. Vijay Kumar, SHO,

The prime accused Gangaya, during investigation revealed that the deceased was known to him for sometime. From the investigation conducted initiative, Elderline so far, it is found that due to some tussle, he harbored personal grudges against him and had created an elaborate plot to murder him. For this, Gangava made extensive arrangements and he roped in:

A. Ramasubramaniyan, S/o Shri Alagu, 47 yrs, R/o Sivagangai Distt. Tamil Nadu, now at DB Gram, Bithika Mallick, W/o Shri Binoy Biswas, 38 yrs, R/ o Kalipur, Diglipur and M. Ramesh, S/o Shri Murugeshan, 45 vrs, R/o D B Gram, permanent resident of Ramnad Distt. Tamil Nadu.

Bithika Mallick also knew the deceased for sometime, and S. Gangaya used her to lure the deceased to a building on the fateful day i.e. 29.03.2025. As part of his plan, he had also called A. Ramasubramaniyan from Tamil Nadu well in advance to execute his plan. One M Ramesh, a mason by profession was also looped in for the execution of the crime and destruction of evidences.

On 29.03.2025 at around 08.15 PM, the deceased arrived at the decided location. The accused persons, as per the premeditated plan, brutally assaulted and murdered Sahadev Dev. His body was then shifted to an under construction hotel site of Gangaya located at D.B. Gram and the body was fully burnt. Elaborate efforts were made by the accused persons to conceal the heinous crime and destroy all the evidences.

Subsequent to registration of the case, the Forensic team was immediately called to Diglipur and the team of experts successfully lifted vital Forensic evidences which have prima facie linked the accused to the Crime.

On the basis of technical and scientific investigation, the exact place of murder has been identified. Weapon of offence and clothes worn by the accused during the commission of the crime have been recovered. Despite multiple attempts by the accused to mislead the Police, the bag and mobile phone of the deceased have also been successfully recovered after extensive efforts of the team.

From the investigation conducted so far, it has emerged that S. Gangava is the main Conspirator and mastermind behind the cold blooded murder. He roped in three other accused persons as mentioned above also to commit the crime and destroy the evidences.

Further investigation of the case is under progress. The seized exhibits will be sent to Forensic Science Laboratory, Sri Vijava Puram and other Central Forensic Science Laboratories for technical and biological corroboration. The accused persons have been produced before the Hon'ble Court and have been remanded to judicial custody. Investigation will be finalized at the earliest and a chargesheet will be submitted in the Hon'ble


