



Provided that in case a Union Territory does not have a Legislative Assembly, the Government concerned shall have the discretion to nominate two members from any of the other categories mentioned above.

The names sponsored in the above manner shall duly be considered by a Screening Committee constituted by the A&N Administration and the short listed names will be placed for consideration of the Competent Authority.
