



#### **General Elections-2024: Model Code of Conduct**

#### ECI issues instructions to regulate road shows to avoid any inconvenience to general public/commuters

Port Blair, Apr.12

With the announcement of General Elections-2024 by the Election Commission of India on 16/03/2024, the Model Code of Conduct has come into force with immediate effect.

In this regard, the Election Commission of India has issued the following instructions to regulate road shows to avoid any inconvenience to the general public/commuters during road shows which is detailed as under :-

- Prior permission for road shows shall be taken from the Competent Authority.
- In order to avoid inconvenience to general public, as far as possible, road shows, subject to court orders and local laws, should be permitted only on holidays and during no-peak hours on routes other than that having big hospitals, trauma centers, blood banks and heavily crowded markets.
- Number of vehicles and persons joining for road show shall be intimated in advance.
- The road show shall not cover more than half the road width to
- ensure safety of the general public. The convoy of vehicles being used in road show shall be broken
- after every 10 vehicles and a gap of 100 meters would be maintained.
- Safety of public and persons in the road show shall be ensured. Bursting of fire crackers and carrying of fire arms shall not be permitted at all.
- The maximum size of banner to be carried with hand would be 6x4 feet.
- Loudspeakers can be used as per existing ECI's instruction and subject to local Laws and Court orders on this subject.
- Display of animals in road shows is totally banned. Children, particularly school children in uniform, should not take part in road shows.
- Only one flag of the size 1 ft x  $\frac{1}{2}$ ft with permission of the RO concerned would be allowed on campaign vehicles in a

The above mentioned instructions have to be adhered to by the respective Political Parties/Candidates to avoid any inconvenience to the general public, a press release from District Election Officer (SA) said.

In Nicobar District, 5 teams were deputed, out of which, 01 in Car Nicobar, 02 in Nancowry & 02 in Campbell Bay Tehsil, wherein 27 votes were cast through postal ballots in the category of absentee voters, out of which, 21 voters were in Senior Citizen (85+) category, 06 voters were PwD voters (Benchmark Disability 40% and above).

#### Dead body kept in GB Pant **Hospital Mortuary for** identification

Information was received on March 17, 2024 that a male dead body was floating near Science Center, Sea Shore. Upon this, the Police Party rushed to the spot and recovered a male dead body from the spot. The description of the deceased is height approximately 5 feet 3 inch, body colour sallow, well built, wearing apparel is a dark navy blue color jeans short and a black with grey color strip innerwear. Upon this, a UD FIR vide No 16/2024 dated 17/03/2024 U/s 174 Cr.P.C has been chalked out at Police Station Aberdeen.

During the course of investigation, rigorous efforts were made for the identification of the deceased by flashing signal and enquiry from the local informers and nearby local residents of the area, but no fruitful result hs been obtained. After post-mortem as per procedure, the Doctor concerned, suspected that the body might be of a Mongolian tribe.

Since the deceased is still unidentified and no relative has come forward to claim the dead body for last rituals. The dead body has been kept in the cold mortuary of G. B. Pant Hospital for identification.

The general public have been requested to inform Police on telephone numbers 100, 232400 & 232405, for any information concerning the above mentioned dead body, a press release from SP (SA) said.
