## Instrument Landing System becomes operational at VSI Airport Paves way for operation of aircraft at night, low visibility and bad weather conditions with safety

Port Blair, Apr. 20

It was a historical moment for Civil Aviation in the Andaman & Nicobar Islands as Instrument Landing System (ILS) has become operational at Veer Savarkar International Airport, Port Blair from April 18, 2024. Indigo flight 6E 526 was the first flight which landed using ILS approach at 6.29 am under the command of Captain Jaya Kumar Munuswamy.

Operationalization of ILS has made the runway to a precision approach runway and paved the path for civil aircraft operations at night, low visibility and bad weather conditions with safety. It will reduce flight diversions and enable



the extension of aircraft operations time window. This infrastructure will also assist the safe landing of aircraft in day time also.

Airport Director, Shri Devendra Yadav said that it is a historical achievement in unlocking the true potential of the Airport. It

is a strategic investment by Airports Authority of India for strengthening the air navigation infrastructure and elevating the safety of aircraft operations. Airports Authority of India has been working on this project for the last 10 years. With continuous efforts and

perseverance, ILS has been made operational at Port Blair Airport, he said.

ILS is revolutionary navigation aid which will revolutionize air travel in the Andaman & Nicobar Islands and will pave the way for smoother and safer flight operations during the low visibility, night and bad weather conditions. Considering the



geographical location of Andaman and Nicobar Islands, ILS is a kind of necessity for safe flight operations.

Due to the weather conditions of Andaman & Nicobar Islands, there are significant flight diversions, which has cost implications to the airlines and

On completion of Polling, Polled EVMs and VVPAT machines from Port Blair and Ferragunj Tehsils were brought amidst full security and stored in the Strong Room at JNRM yesterday itself.

Today, Polled EVMs and VVPAT machines from



Swaraj Dweep, Shaheed Dweep, Rangat, Little Andaman and Car Nicobar arrived and have been kept in the Strong Room. While storing the polled materials, the SOP issued by the Election Commission

was followed in letter & spirit. The CRPF alongwith the Executive Magistrates are accompanying the Polled Materials on its return journey to the Strong Room at JNRM.

The entire

operation of receiving the Polled materials from different Tehsils is being done under the supervision of CEO, ANIPC, Shri B.S. Jaglan, IAS, RO, Shri Arjun Sharma, IAS, Observers and other Election & Police Officials. The Political Parties, Contesting Candidates or their representatives are being informed during the storage of Polled EVMs and VVPAT machines to up-keep utmost transparency in the procedure of storing

the polled materials.

Elaborate security arrangements have been put in place at JNRM for the safety of Polled Materials and the security of the Strong Room are being looked after 24x7 by A&N Police personnel and CRPF. Meanwhile, the Polled EVMs and VVPAT machines from Mayabunder, Diglipur and Campbell Bay are expected to reach Port Blair on April 21 & 22 respectively.

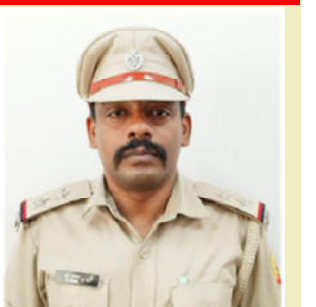

migrant labourers residing in this UT who have been registered on e-Shram portal of the Labour Department and have not yet received their Ration Card either in their native State/UTs or in the UT of Andaman & Nicobar Islands.

The Department has also constituted area wise teams for organizing Special Camps in close coordination with the elected representatives of the respective Gram Panchayats and Municipal Wards. Left out migrant labourers may also approach the Directorate of Civil Supplies & Consumer Affairs and the respective Supply Units of other Islands with valid document required for Ration Card.

A&N Police issues advisory on fraudsters using armed forces personnel details to perpetrate financial cyber frauds

A new trend in financial cyber fraud has been observed where fraudsters impersonate Indian army personnel to exploit the goodwill associated with the armed forces to siphon off money from innocent victims who have advertised to put their property (House, Flat, Rooms, etc. on rent) on the popular house renting websites/apps, real estate database website or social media websites, etc.

In this regard, Andaman and Nicobar Police has issued the following advisory to safeguard the citizens:

Always remember that entering OTP is a requirement for sending money, not for receiving it.



If an unknown person makes contact for renting your house, flat, or rooms, etc., try to confirm his/her identity from other available methods/sources.

Fraudsters typically show urgency in their requests. Scrutinize, if a request seems too urgent.

Avoid relying on conversations and identity details provided by unknown people on messaging apps, house renting platforms, etc.

Scrutinize every transaction request

made to you from people unknown to you.

Captiously perform transactions on various online transaction platforms, aware yourself with all the features of payment gateway.

resulted in apprehension of foreign boat carrying 14 crew. This also led to recovery of substantial quantity of sea cucumber from the boat.



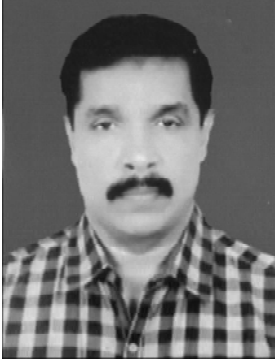

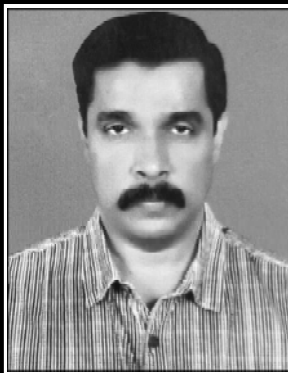
