Regarding specialized treatment provided at GBPH, it was informed that so far, 621 Angiography (Coronary), 12 Angiography (Pheripheral), 200 Angioplasty, 80 pacemaker and 10 cardiocentesis were done. This advanced facility for heart related ailment has been made available here in Port Blair itself, thereby saving Island patients from incurring huge amount for treatment at mainland. AV Fistula has also been started in GBPH which is a great advantage for the patients requiring fistula surgery. Due to improved medical facilities, the referral cases to mainland has come down to 40% in the last one and half year.

During the press conference, it was also informed that 2 Basic Life Saving (BLS) Ambulance and 1 Advanced Care Life Saving (ACLS) Ambulance will be procured for the benefit of the islanders to cater to emergency cases. Further, it was disclosed that ANIIMS will apply for PG courses in multiple disciplines for the academic year 2025-26. It has also applied for accreditation for DNB Courses with National Board of Examination (NBEMS) in five disciplines (i.e. General Medicine, General Surgery, OBG, Pediatrics and Anesthesiology)

Companies, etc.). Under Cold Chain Scheme, financial assistance in the form of grants-in-aid/subsidy is provided @ 35% of eligible project cost for projects in general areas and 50% of eligible project cost for projects in difficult areas as well as for projects of SC/ST, FPOs and SHGs, subject to the maximum of Rs. 10.00 crore per project.

MoFPI has been establishing cold chain projects under the cold chain scheme by inviting proposals across the country through floating Expression of Interests from time to time based on availability of funds. The consent of State Governments is not required for storage of food commodities in the cold chain projects approved by MoFPI. However, the assistance of the State Governments is required for obtaining statutory approvals essential for establishing the projects by the project implementing agencies.

- **A** (i) Common Telecom Infrastructure (CTI) shall be mandatory for all public places like Airports, commercial complexes and residential complexes.
- (ii) Every person/applicant while submitting the application for approval of Building Plan shall mandatorily demarcate sections within buildings and on rooftops for housing of Broadband digital connectivity infrastructure/antenna. These areas shall have continuous power supply for reliable and always-on services.
- (iii) The Owner/RWA shall make available the required access to Common Telecom Infrastructure (CTI) facilities inside the building to all Service Providers on a fair, transparent and non-discriminatory manner.
- (iv) The Owner /RWA shall not consider the CTI facilities as a source of revenue generation but as a means for facilitating penetration broadband access and thereby helping in socioeconomic growth of all the residents.
- (v) The Charges like rentals/power etc. to be levied upon the TSPS/ IP-1s shall be fair, transparent and non-discriminatory.
- **B**.(i) The minimum requirement of Common Telecom Infrastructure space to be provided in the buildings with Built-Up Area range shall be as below:-




