Recognizing the importance of building the necessary infrastructure and expertise in this area, the Andaman & Nicobar Police has moved swiftly to ensure that its Investigating Officers and Scientific Officers from the Forensic Wing are equipped with the skills and knowledge required to meet these new standards.

As part of its strategy to enhance forensic capabilities, the Andaman & Nicobar Police submitted a proposal to the Andaman & Nicobar Administration for the execution of a Memorandum of Understanding (MoU) with the National Forensic Sciences University (NFSU), Gandhinagar, Gujarat. This prestigious university, is a Central Institution established in 2008, is recognized by the University Grants Commission (UGC) and has been accredited with an "A" grade by the National Assessment and Accreditation Council (NAAC).National Forensic Sciences University (NFSU)is recognized as an Institution of National Importance under the Ministry of Home Affairs (MHA), Govt. of India, by an act of the Indian Parliament. NFSU is solely dedicated to Forensic Science, Investigative Science and Criminology.

The proposal received approval from Hon'ble Lt. Governor, A&N Islands and Chief Secretary, A&N Administration, underscoring the administrative support and the strategic importance of this collaboration.

With the approval secured, the Andaman & Nicobar Police is now poised to execute the MoU with NFSU. The signing ceremony, which will formalize this strategic partnership, is scheduled to take place shortly and will be executed between Director General of Police, Andaman & Nicobar Police, and the Campus Director of the National Forensic Sciences University.

This collaboration is expected to significantly bolster the forensic capabilities of the Andaman & Nicobar Police, ensuring that its officers are well-prepared to effectively implement the new criminal laws.

It is also noteworthy that the Andaman & Nicobar Police has recently entered into an MoU with the National Law School of India University (NLSIU), Bengaluru, to provide specialized training on the New Criminal Laws to its Investigating Officers. This initiative, along with the forthcoming partnership with NFSU, underscores the commitment of the Andaman & Nicobar Police to continuous professional development and the enhancement of law enforcement standards in the region, a press release from A&N Police said .

1 more Foreign Poacher apprehended by North & Middle Andaman District Police

Diglipur, Aug. 10

During the on-going anti - poaching operations in the N&MA District, another foreign poacher was successfully apprehended by the dedicated team near the Gopen Nallah jungle, within the jurisdiction of PS Kalighat on 09/08/2024.

The anti-poaching team, constituted under the leadership of SI Ashok Baghel, SHO PS Kalighat, and led by ASI Vijay Kumar Ekka, along with HC Suresh Guria and Constables Ajay Das, Arun Dung Dung, Sachin, Sanjay Barla, Suhas Ingle, Anirudh Naik, Joginder, and Sandeep Kumar, has been relentlessly conducting combing operations against

foreign poachers since 01/08/2024. As a result of these efforts, one poacher and a dinghy were apprehended on 01/08/2024.

On 09/08/2024, during an extensive and continuing combing operation, the team discovered a poacher hiding in the Gopen Nallah jungle. The team acted swiftly and apprehended him. Due to the poor health condition of the apprehended poacher, he was immediately hospitalised and is currently receiving treatment. Once the poacher is discharged from the hospital, he will be handed over to PS CCS for further investigation. Meanwhile, the anti-poaching team

continues its search for more poachers in the area.

This successful operation is a testament to the dedication and effectiveness of the anti-poaching team in safeguarding our territory and protecting our rich wildlife resources from foreign intruders. The bravery and commitment displayed by the team have been lauded, and they will be suitably rewarded.

depending on crops in that area, in the field after harvesting against cyclone, cyclonic rains and unseasonal rains.

All farmers including share croppers and tenant farmers growing the notified crops in the notified area are eligible for coverage. Such farmers are required to submit the necessary documentary evidence of land records prevailing in the UT (record of right, land possession certificate) or other document notified/permitted by the UT.

The cut-off date for the enrolment under the scheme for Kharif 2024 is 15.08.2024. The farmers have to approach the SBI or Co-operative Bank of concerned areas along with land records and enroll under the scheme or they may even register themselves in the National Crop Insurance Portal (NCIP) i.e. pmfby.gov.in.

After enrolment, any losses to the crop arising out of risks may be intimated immediately (within 72 hours) by the insured farmer directly or through his own mobile or land line phone or any of his own media or toll free numbers ,if any, to the Implementing Agency (The Kshema General Insurance Limited) , concerned bank, local Agriculture Department. For any assistance or queries, farmers have been encouraged to contact Kisan Call Centre Help Line No. 243434/18003451145 or approach the Officers/ Staff of Department of Agriculture in various zones. The farmers of Andaman and Nicobar Islands have been appealed to take maximum benefits of PMFBY, a press release from Agriculture Department said.


