



The AH&VS Department plans to procure semen straws of superior goat breeds, such as Beetal and Sirohi, to upgrade local varieties through AI. This effort is part of the Department's broader strategy to enhance goat development in the Union Territory, boosting meat and milk production and improving the socio-economic status of rural and tribal communities, a press release from Deptt. of AH&VS said.


