Parliament passes Promotion and Regulation of Online Gaming Bill, 2025

Bill encourages e-sports & online social games while prohibiting harmful online money gaming services

New Delhi, Aug. 21

Parliament has passed the Promotion and Regulation of Online Gaming Bill, 2025, with the Rajya Sabha approving it today. This Bill encourages e-sports and online social games while prohibiting harmful online money gaming services, advertisements, and financial transactions related to them. It has the provision for the appointment of an Online Gaming Authority for coordinated policy support, strategic development and regulatory oversight of the sector.

The objective of the Bill is to protect individuals, especially youth and vulnerable populations, from the adverse social, economic, psychological and privacy related impacts of such games. The Bill has



a provision of complete ban on offering, operating, or facilitating online money games. There is a provision of imprisonment up to three years and fine up

to one crore rupees or both in case of violation of the law related to online money gaming. Moving the Bill, Minister, Shri Ashwini

Vaishnav said online money gaming has become a public health menace. He said, several families have faced financial distress due to online money gaming. The Minister highlighted that online money gaming posed a serious concern in the society as it creates addiction leading to financial frauds and cheating. He said, an estimated 45 crore people lose around 20 thousand crore rupees every year in the online games. Shri Vaishnav highlighted that the bill has three segments namely E sports, online social games and online money games. He said, Government will promote E sports and online social

Hon'ble MP meets Hon'ble Prime Minister; highlights various issues pertaining to A&N Islands

New Delhi, Aug. 21

In order to secure early and sympathetic consideration of the most pressing issues pending before the Government of India, Shri Bishnu Pada Ray, Hon'ble Member of Parliament, Andaman & Nicobar Islands, today met the Hon'ble Prime Minister, Shri Narendra Modi at Parliament in New Delhi.

During the meeting, Shri Bishnu Pada Ray recalled and reiterated some of the critical matters that he has already submitted in writing to the Government for urgent intervention and decision. A written memorandum was also handed over to the Hon'ble Prime Minister for record and necessary action.

The key issues highlighted before the

Hon'ble Prime Minister were:

- ♦ Framing of Domicile Law & Upper Age Limit for Employment: Introduction of a domicile law ensuring 100% job reservation for islanders and enhancement of upper age limit to 40 years for local candidates, on the lines of provisions already implemented in Ladakh UT.

- ♦ Enhancement of Budget Allocation for A&N Islands: Substantial increase in budget allocation under the Capital Head. At present, only Rs. 162 crore has been allocated for 40 Departments, which is inadequate for critical infrastructure development such as roads, water supply, healthcare, electricity, Panchayati Raj Institutions, and urban development.

- ♦ Relaxation of population ratio under PMGSY-IV: Grant of relaxation in the population norm from 250 to 100 for sanctioning of rural roads under PMGSY-IV, considering the unique geographical conditions of the Islands. Reducing the population ratio to 100 will ensure inclusion and help address the critical connectivity needs of our remote Islands.

Shri Bishnu Pada Ray expressed his deep gratitude to the Hon'ble Prime Minister and stated that the people of Andaman & Nicobar Islands repose great hope and confidence in the visionary leadership of the Hon'ble Prime Minister for ushering in a brighter and more developed future for the Islands, a press release from MP Office said.

District Administration, SA evicts unauthorized encroachment & restores Govt. land at School Line village

Vessel Nalanda safely berthed at Katchal Port despite inclement weather

Sri Vijaya Puram, Aug. 21
The Directorate of Shipping Services has announced the resumption of vessel services to Katchal Island, marking a significant milestone in strengthening maritime connectivity for the residents of the Nicobar District.

The Directorate of Shipping Services has been providing essential shipping link between Sri Vijaya Puram and Katchal Island through the vessels Nalanda and Sindhu. However, these services were temporarily suspended due to operational constraints and the annual monsoon season. This decision was taken with paramount consideration for the safety of passengers, crew, and vessels in view of adverse weather conditions and challenging sea state.

The Directorate of Shipping Services received numerous

representations from the residents of Katchal Island and community leaders requesting the revival of this critical service. Responding to this public demand and following a comprehensive review of operational feasibility, the Directorate of Shipping Services undertook concerted efforts to address the matter.

Considering specific request of the commuters of Katchal Island, the Directorate instructed the Master of Nalanda to include a scheduled call at Katchal Port during her voyage from Sri Vijaya Puram to Campbell Bay via Nancowry on August 19, 2025.

Through exemplary seamanship and meticulous planning, the Master and crew of Nalanda carried out the directive with utmost regard for safety.

Despite persistent inclement weather conditions, the vessel

undertook the voyage with all necessary precautionary measures in place. It is informed that Nalanda safely berthed at Katchal Port on August 20.

This successful operation underscores the Directorate's commitment to meeting the needs of Island communities while maintaining its foremost priority of ensuring safety. The resumption of services to Katchal, even on a call-by-call basis, is a testament to our continued efforts to ensure that islanders remain connected and supported.
