NHSC & Social Welfare Department ensure elderly well-being in Isles

Helpline 14567 offers Free Guidance, Support & Field Assistance to senior citizens

Sri Vijaya Puram, Aug. 3

The Ministry of Social Justice & Empowerment (MoSJE), Government of India, through the National Institute of Social Defence (NISD), in collaboration with the Directorate of Social Welfare, A & N Administration, and the service provider, Alankit Assignments Limited, New Delhi, has launched the National Helpline for Senior Citizens - Elder Line 14567, under the Atal Vayo Abhyuday Yojana.

This vital initiative aims to ensure the safety, dignity, and well-being of elderly citizens across the country. In the Union Territory of Andaman & Nicobar Islands, the helpline is operational since 24th December, 2024 and functions daily from 8 AM to 8 PM from the WCD Control Room building, VIP Road, Junglighthat.

The helpline, accessible via the toll-free number 14567, provides free services including information, guidance, emotional support, and field-level interventions. It serves as a critical response system to address the concerns, grievances, and needs of the elderly. Through this platform, elderly citizens are given a voice and a channel for support, intervention, and protection.

Since its inception, the National Helpline for Senior Citizens (NHSC) has received over 500 calls. Out of these, 103 calls were officially registered and 101 cases have been successfully resolved. The nature of issues addressed includes requests for



information, emotional support, complaints of physical and mental abuse, economic neglect, health-related problems, chronic illnesses, and other welfare concerns. Each case has been handled with compassion, urgency, and appropriate field action to ensure that senior citizens receive the attention and services they rightfully deserve.

In one notable intervention, NHSC responded to a complaint regarding the prolonged waiting times faced by senior citizens at the State Bank of India. Acting promptly, NHSC personnel engaged directly with SBI officials and submitted a formal request, leading to the successful

introduction of a separate queue for senior citizens at the bank. This small yet significant step has greatly improved the ease of access to banking services for elderly individuals and restored their sense of dignity.

Additionally, the NHSC team conducted Ayushman Bharat Card enrolment drives at five key locations: Ullas Old Age Home, Abhyudaya Complex Old Age Home, Chinmaya Mission, Haddo Ward No. 2, and Wimberlygunj Panchayat Hall. These efforts have so far benefited over 150 senior citizens, enabling them to access essential healthcare services under the Ayushman Bharat scheme. For those who were bedridden or unable to travel, NHSC coordinated with the Directorate of Health Services to ensure doorstep delivery of these services, allowing elderly individuals to receive their cards without the need to leave their homes.

Further, NHSC identified two vulnerable elderly families through Chinmaya Mission and extended monthly ration support to them, offering much-needed relief during times of hardship. These efforts reflect NHSC's unwavering commitment to social inclusion, healthcare access, and financial support for the elderly population of the Islands.

The Directorate of Social Welfare and NHSC remain steadfast in their mission to provide a secure and supportive

ANPCC extends deadline for industrial units to obtain direct CTO till Oct. 31, 2025

The Andaman and Nicobar Pollution Control Committee (ANPCC) has extended the deadline for industrial units that were established without prior pollution clearance to regularize their operations. In its XXXIV meeting held in May 2025, the committee decided to allow such units to apply for Consent to Operate (CTO) directly without obtaining prior

Consent to Establish (CTE)-till 31st October, 2025.

As per the Water (Prevention and Control of Pollution) Act, 1974, and the Air (Prevention and Control of Pollution) Act, 1981, no industry is permitted to be established or operated without obtaining CTE and CTO from the State Board. Furthermore, under the Environment (Protection) Act, 1986,

Empowering silence with sound Special Hearing Aid Camp by Education Department brings new hope to children with hearing impairment

26 hearing aids fitted for needy students marking a major step in supporting auditory & educational development

Sri Vijaya Puram, Aug. 3

In a heartening stride towards inclusive education, the Education Department of the A&N Administration organized a two-day Special Hearing Aid Distribution and Fitting Camp, illuminating the lives of children with hearing impairment. Held on 1st August, 2025 at Government Girls Senior Secondary School, Sri Vijaya Puram, and on 2nd August at the Deputy Education Office, Wimberlygunj, this initiative stood as a beacon of early intervention, aiming to ensure that every child



is heard and supported in their educational journey.

This impactful initiative was aimed at the early identification, intervention, and support for children with hearing impairments. The camp brought together a multidisciplinary team of experts from the

Medical, Rehabilitation, and Education Departments to comprehensively assess students and recommend personalized solutions that could significantly enhance their communication and learning abilities.

Leading the camp was Dr. Ravi Kapoor,

Senior Audiologist from the Government Medical College Hospital, Chandigarh, whose vast experience proved instrumental in ensuring detailed and accurate evaluations. He was ably supported by an ENT specialist and audiologist from GB Pant Hospital, adding further clinical depth

and expertise to the process.

Over the course of the two-day camp, a total of 31 students with hearing impairments underwent thorough audiological and ENT evaluations. Based on clinical assessments, customized recommendations were

compliance with these regulations is mandatory.

The ANPCC has observed that several industrial units in the Andaman and Nicobar Islands have been set up and are operational without acquiring the necessary pollution consents. This constitutes a violation of the aforementioned Acts. While a previous compliance window was provided to such units, the committee continues to receive CTO applications without prior CTE, prompting the extension.

The CTO will be issued only if the industrial unit meets all applicable environmental norms. The ANPCC emphasized that no CTO applications will be entertained after 31st October, 2025 from units that failed to obtain CTE prior to establishment.

All stakeholders and industrial entrepreneurs are reminded that it is a statutory requirement to obtain CTE before establishing an industry and CTO before commencing operations. Applications for both consents must be submitted online via the portal: www.anocmms.nic.in.

Failure to comply within the extended timeline will invite strict action under the Environment (Protection) Act, 1986, a press release from ANPCC said.

4. Class X (High School) Board Certificate as proof of date of birth.
5. Certificate and Mark sheet of qualifying examination.
6. Category Certificate (ST Certificate/Local Certificate/Service Certificate).
7. Duration/Bonafide certificate issued by the respective school.
8. Certificate for Persons with Disabilities (PwD) and/or Unique Disability Identity Card (UDID), if applicable. The certificate should be issued from a duly constituted Medical Board. The certificate should stand valid up to 31.12.2025. Certificate not issued by a medical board &/or getting expired before 31.12.2025 shall not be accepted.
9. Proof of place of examination center in case of final qualifying examination is from the National Institute of Open Schooling (NIOS) formerly known as National Open School

(NOS).

The eligible interested candidates are required to bring all educational qualification certificate/testimonials and other documents in support of their category in original along with one self attested copy as prescribed by the CSAB NEUT-2025 in their Information Brochure for spot round counselling on the date time and venue as specified above. In addition, the candidates are also requested to bring two passport size photograph identical to the one pasted on the JEE (Main)-2025 application form.

Further, the aspiring students are advised to ensure that he/she fulfils the state eligibility criteria during Spot Round Counselling.
