Parliament passes Central **Excise (Amendment) Bill 2025** to raise Tobacco Duties

Bill aims to protect people from ill effects of tobacco & discourage them from its consumption

Parliament today passed the Central Excise (Amendment) Bill, 2025 with the Rajya Sabha approving and returning it to the Lok Sabha. The legislation is aimed to amend the Central Excise Act, 1944, specifically to raise excise duties and cess on tobacco products such as cigarettes, cigars, hookah tobacco, chewing tobacco, zarda and scented tobacco. The amendment is required to give the Government the fiscal space to increase the rate of central excise duty on tobacco and tobacco products so as to protect tax incidence, after the cess ends. Minister of State for Finance, Shri Pankaj Chaudhary moved the



increase central excise duty on unmanufactured tobacco, manufactured tobacco, tobacco products, and tobacco substitutes. While the Central Excise Act, 1944 levies an excise duty ranging between 200 rupees and 735 rupees per the duty on chewing tobacco

Hon'ble MP meets Hon'ble Union Minister

The Bill is intended to thousand cigarettes, the enhanced duty under the Bill ranges between two thousand 700 rupees and 11 thousand rupees per thousand cigarettes. The Bill also prescribes higher excise duties for manufactured tobacco products. For instance,

will increase from 25 percent to 100 percent. Duty on hookah will increase from 25 percent to 40 percent. For smoking mixtures for pipes and cigarettes, the duty is proposed to be increased from 60 percent to 325 percent. The purpose of the bill is to protect people from the ill effects of tobacco and to discourage them from its consumption.

Replying to the discussion in Rajya Sabha, Finance Minister, Ms Nirmala Sitharaman stated that higher duties on cigarettes will be shared with the States. The Minister said this is not a cess but excise duty. She stressed that the amount will be redistributed to the States as per the Finance Commission's recommendations. She assured that the Bill will not harm tobacco farmers and beedi workers. She added that there are many schemes, including crop



FMD is a highly contagious and infectious disease affecting cloven-hoofed animals such as cattle, buffaloes, sheep, goats and pigs. The disease presents clinical signs such as high fever (104-106 degrees Fahrenheit), loss of appetite, dullness, excessive salivation, vesicles in the mouth (particularly on the gums and tongue) leading to ulcers, and wounds in the hoof, especially in the inter digital space. Blisters may also appear on teats.

FMD results in significant economic losses due to reduced milk yield, decreased growth rate, and infertility. Transmission occurs through excretions and secretions from infected animals and can be spread mechanically by animals, humans, vehicles, and other contaminated objects.

The World Organization for Animal Health (WOAH) has classified FMD as a Schedule-A disease. No outbreak of FMD has been reported from this Union Territory since last 6 years. The Department of AH&VS is committed to keep the territory free from FMD.

The Department of AH&VS has requested all livestock owners to cooperate fully and ensure their animals are ear-tagged and vaccinated against FMD to help make the Island FMD- free, a press release from Department of AH&VS said.


