## PM Surya Ghar: Muft Bijli Yojana delivers Zero Electricity Bills to over 7.7 Lakh households: Minister Rs.13,926 Crore subsidy support and over 8.3 Lakh loan applications sanctioned under PMSG: MBY



New Delhi, Dec. 16 (PIB)

The Government of India launched PM Surya Ghar: Muft Bijli Yojana (PMSG: MBY) in February, 2024, aiming to achieve rooftop solar (RTS) installations in one crore households in the residential sector by FY 2026-27 with an outlay of Rs 75,021 crore.

As on 09.12.2025, a total of 19,45,758 RTS systems have been installed across the country, benefitting 24,35,196 households.

To ensure the economic profitability and cost-effectiveness of RTS systems for beneficiaries, apart from Central Financial

Assistance collateral free loan @ interest rate of 5.75% (Repo rate plus 0.50 bps) is available for installation of RTS systems.

In addition, to promote adoption of the PMSG: MBY for rural households or the economically weaker sections, Ministry has

issued guidelines for installation of RTS systems under Utility Led Aggregation (ULA)/ RESCO model.

This information was submitted by Union Minister of State for New and Renewable Energy, Shri Shripad Yesso Naik in a written reply in Rajya Sabha today.

Andaman and Nicobar Islands, an official said.

Another group has won the bid to develop the existing Megapode Resort in Sri Vijaya Puram on a PPP mode, the official said.

The Andaman and Nicobar Islands Integrated Development Corporation Limited (ANIIDCO) has finalised three applications to design,

build, finance, operate, transfer (DBFOT) of 5-star eco-tourism resorts on PPP basis at these exotic locations, the official said.

"In a major stride toward sustainable tourism-led growth, we have finalised successful tenders for four flagship eco-tourism projects across the Islands. Three hospitality groups/

## Boost to livestock productivity & dairy farmers' livelihoods in remote areas Chief Secretary launches 'Pashu Pushti Kit'- a pilot project to boost milk production in N&M Andaman

Sri Vijaya Puram, Dec. 16

In a significant step towards enhancing livestock productivity and improving the livelihood of dairy farmers in the remote areas of the Islands, Dr. Chandra Bhushan Kumar, IAS, Chief Secretary, A&N Administration, today launched the pilot project of "Pashu Pushti Kit" - a specially designed nutritional supplementary kit for dairy animals - at Nabagram Village in Diglipur Tehsil, North & Middle Andaman.

Speaking on the occasion, the Chief Secretary appreciated the innovative approach of the Department and emphasised that successful implementation of the pilot project would pave the way for expansion to all milk-producing villages across the Islands. He directed that financial benefits arising from improved milk quality and quantity be



passed on directly to the farmers.

The initiative, conceptualised and implemented by the Department of Animal Husbandry and Veterinary Services, directly addresses malnutrition-related infertility in cattle,

which has emerged as a major constraint to milk production in the Islands. Extensive field surveys conducted through 168 mass infertility treatment camps between June and September 2025 revealed that malnutrition accounts for nearly 24

percent of infertility cases among the examined animals, with the problem being particularly acute in North & Middle Andaman where 47.75 percent of cases were linked to nutritional deficiency compared to 26 percent in South Andaman.

Out of 4,917 animals examined across 174 villages in North, Middle and South Andaman as well as Campbell Bay, 1,140 cases were attributed to malnutrition. The Department estimates that treating infertility through improved nutrition can add an impressive 15 lakh litres of milk annually to the Islands' current

production of 17.61 metric tonnes. The "Pashu Pushti Kit", prepared utilising existing stock of quality supplements, contains chelated mineral mixture, mineral blocks for licking, ayurvedic

investors have won the bid to build three luxury eco- friendly tourism resorts at Long Island, Aves Island and Shaheed Dweep. Letters of Award for the development of eco- tourism resorts have been issued. We also got one of the highest bidder to develop the existing Megapode Resort in Sri Vijaya Puram on PPP mode," an official said.

"In addition to the annual concession fee, concessionaires will share revenue at the rates of 3.6 per cent for Megapode Resort, 3 per cent for Shaheed Dweep, and 2 per cent each for Long Island and Aves Island. The concession period is 50 years for Megapode Resort and 75 years for the other projects, including construction time," he said.

"Our aim is the archipelago as a premier global destination for responsible, nature-centric tourism. These projects are designed to meet international sustainability standards, including LEED, GRIHA, and Green Globe certifications, and comply fully with Coastal Regulation Zone (CRZ) and environmental norms," he said.

Emphasising low-impact design, each resort will operate on self-sustaining systems powered primarily by renewable energy, including solar installations, ensuring minimal ecological footprint and seamless integration with the Islands' natural landscapes.

Out of four locations, Aves Island is an uninhabited Island, and this is probably the first time in decades that the local administration has decided to open such an uninhabited Island to promote tourism.

The Aves is a small and beautiful Island, also known as Coconut Island for its lush green coconut plantation. Presently, Aves is not open for tourists. It is an uninhabited Island with no accommodation facilities, but with the proposed five- star eco-tourism resort, Aves will be the most sought-after tourist destination after Swaraj Dweep in Andaman.

With an investment of nearly Rs 36 crore, the five-star eco-tourism resort (2.75 hectare) at Aves Island will have 50 rooms where the concessionaire can undertake various activities like a shopping area for local souvenirs, scuba diving, game fishing, forest trekking, nature camping, wellness centre, etc.

Apart from Aves, the resort at Long Island (total project cost of five five-star eco-tourism resort will be approx Rs 391 crore) will have a maximum of 220 rooms, while Shaheed Dweep (total project cost will be approx Rs 172 crore) will have a total of 120 rooms. Indian Navy commissions DSC A20 at Naval Base, Kochi

New Delhi, Dec. 16 (PIB)

The Indian Navy commissioned DSC A20, first of the five Diving Support Craft (DSC), built indigenously by M/s Titagarh Rail System Limited, during a ceremony held at Naval Base, Kochi today.

The event was presided over by Vice Admiral Sameer Saxena, Flag Officer Commanding-in-Chief, Southern Naval Command and hosted by Vice Admiral Sanjay Sadhu, Controller of Warship Production and Acquisition, with senior naval officers, representatives of M/s Titagarh Rail System Limited, Kolkata and distinguished guests



in attendance. The contract for building five Diving Support Craft, was signed between MoD and M/s Titagarh Rail System Limited, Kolkata on 12 Feb 21. The Hydrodynamic Analysis and Model Testing of the ship during design stage, was undertaken at Naval Science and Technological Laboratory (NSTL), Visakhapatnam. DSC A20 has been designed and constructed as per the classification rules of Indian Register of Shipping (IRS). It is a catamaran-hull ship, with a displacement of approx 390 Tons . Fitted with state-of-the-art Diving Equipment, the vessel would play a vital role for underwater repairs & inspections, harbour clearances and critical diving missions in coastal waters.

stomachic and appetite stimulant powder, probiotic or liver tonic, protein extract or calcium supplement, and concentrated feed as a base for mixing. Each kit, costing approximately Rs 210 excluding stock medicines, is expected to correct nutritional deficiencies, bring infertile cows back into the production cycle, increase the number of milch animals and significantly enhance both milk yield and quality.

Nabagram Village was selected for the pilot launch because of its remote location, limited access to concentrate feed and supplements, substantial breedable cattle population of around 191, and the presence of 89 farmers already supplying milk to ANIIDCO, which will enable precise monitoring of results through daily milk collection data.

The Department of AH&VS thanked the Chief Secretary for his continued support to livestock development programmes and reiterated its commitment to making dairy farming more remunerative and sustainable for the rural population of Andaman & Nicobar Islands, a press release from Deptt. of AH&VS said.
