Lok Sabha passes Viksit Bharat-Guarantee for Rozgar and Ajeevika Mission (Gramin): 'Viksit Bharat - G RAM G Bill 2025' Legislation to replace Mahatma Gandhi National Rural Employment Guarantee Act, 2005

New Delhi, Dec. 18
The Lok Sabha has passed the Viksit Bharat - Guarantee for Rozgar and Ajeevika Mission (Gramin): Viksit Bharat - G RAM G Bill 2025. The legislation will replace Mahatma Gandhi National Rural Employment Guarantee Act, 2005. The Bill seeks to establish a rural development framework aligned with the national vision of Viksit Bharat @2047. Under the legislation, a statutory guarantee of one hundred and twenty-five days of wage employment will be provided in every financial year to every



rural household whose adult members volunteer to undertake unskilled manual work.

The fund-sharing pattern between the Central Government and State Governments will be 60:40 for all States other than the

North-eastern and the biometric Himalayan States, authentication for wherein the sharing transactions, geospatial arrangement will be 90:10. The State Government will continue to pay unemployment allowance and compensation. The bill provides for using

India Begins Work On Second Great Nicobar Airfield Near Malacca Strait

India has initiated preparatory work for building a second airfield on Great Nicobar Island, a strategically located outpost at the mouth of the Malacca Strait that sits astride one of the world's busiest maritime corridors, The Tribune has reported.

The proposed airport will be developed at Chingen near Galathea Bay on Great Nicobar, south of the existing naval air station

INS Baaz at Campbell Bay.

Its proximity to the Six Degree Channel between Great Nicobar and Indonesia's Sumatra

places it closer to shipping lanes that funnel traffic into the Malacca Strait, through which tens of thousands of commercial vessels

pass every year.

The Airports Authority of India is overseeing the project, estimated at Rs 8,573 crore, and has floated tenders for appointing

a project management key component of consultant, with bids the proposed International Container Transhipment Port at Galathea Bay, which is being projected as a future logistics hub in the eastern Indian Ocean. The Union Government has stated that safeguards and mitigation measures have been built into the project design to reduce ecological impact.
