## Revision of Minimum Wages based on variable Dearness Allowance in A&N Islands

Sri Vijaya Puram, Dec. 19

The Hon'ble Lieutenant Governor, Andaman & Nicobar Islands has revised the Minimum Rates of Wages across 6(Six) Schedules of Employments in addition to Govt. Departments/Offices/Industrial Establishments by taking into account the Variable Dearness Allowance (VDA) based on average rise in All India Consumer Price Index as mandated under the provisions of Minimum

Wages Act, 1948 in the UT of A & N Islands w.e.f. 1<sup>st</sup> January, 2026. The Revised Rates of Minimum Wages are as under:-

Category of employee	Minimum wage per day
Unskilled	652.00
Semi-Skilled/Unskilled Supervisory	733.00
Skilled/Clerical	856.00
Highly Skilled	939.00

All employers of the establishments have been requested to comply with the revised rates failing which punitive action as per the provisions of Minimum Wages Act, 1948 along with its Rules made thereunder and subsequently as per the provisions of Code on Wages, 2019 upon its implementation shall be initiated, a press release from Labour Commissioner/DET said.

## Children in the age group of 0-5 years to be administered Polio drops in Isles on Dec. 21

Sri Vijaya Puram, Dec. 19

National Immunization Day (NID) for Polio will be held in A&N Islands on December 21, 2025, covering all the children in the age group of 0-5 years by administering two drops of bivalent Oral Polio Vaccine (OPV) in the Booths followed by house to house visits by the healthcare staff in the next two days to search and vaccinate the missed out / unimmunized children. In this connection, an inaugural ceremony has been scheduled at UHC Junglighat on 21<sup>st</sup> December, 2025 at 08.30 AM, during which two drops of Oral Polio Vaccine will be administered to children by the dignitaries. Ms. Richa, Secretary



(Health)/ Mission Director, UTHM, A&N Administration will be the chief guest on the occasion while Dr. H. M. Siddaraju, Director, Directorate of Health Services will be the guest of honour. This year, it is estimated that around 20666 children will receive the vaccine during the round in 489 booths set up across these Islands including booths in Airport, Sea-port and other transit

points. All tourists and people having children in the age group of 0-5 years will also be covered under this program. Efforts are on to cover 100% of eligible children. The Director of Health Services has appealed to the general public to bring their children in the age group of 0-5 years to the booth for administration of Polio drops on Dec. 21, 2025, a press release from DHS said.

## Insurance coverage to farmers against crop losses due to natural calamities and unforeseen events under PMFBY

### PMFBY notified for Rabi 2025-26 season

Sri Vijaya Puram, Dec. 19

The Pradhan Mantri Fasal Bima Yojana (PMFBY), a flagship scheme of the Government of India, is being implemented in the Andaman & Nicobar Islands since 2016 to provide insurance coverage to farmers against crop losses due to natural

calamities and unforeseen events. PMFBY has been notified for implementation across the Andaman & Nicobar Islands for the Rabi 2025-26 season. Pulses and Vegetable crops have been notified for insurance coverage. One cluster comprising South

Andaman, North & Middle Andaman, and Nicobar (Campbell Bay area only) has been formed for implementation, with an indemnity level of 80% for all notified crops. For the Rabi 2025-26 season, the scale of finance under the Pradhan Mantri Fasal

Bima Yojana (PMFBY) has been fixed at Rs.59,433 per hectare for Pulses, including Green Gram and Black Gram. For Vegetable crops, the scale of finance has been notified as Rs. 1,88,468 per hectare for Tomato, Rs.1,66,404 per hectare for Bhindi, Rs.1,24,419 per hectare for Lobia,

Rs.1,72,742 per hectare for Brinjal, Rs.2,46,047 per hectare for Cauliflower, and Rs.1,47,825 per hectare for Watermelon. The sum insured for each crop shall be calculated by multiplying the applicable scale of finance with the area insured under the

Assistance for farmers under Minor Irrigation scheme

Sri Vijaya Puram, Dec. 19  
The Department of Agriculture, Andaman & Nicobar Administration is implementing schemes for "Development of Minor Irrigation" in Andaman & Nicobar Islands under UT plan. This initiative aims to support individual farmers and co-operative farming societies by enhancing irrigation infrastructure through various forms by providing financial assistance for the following components under the Loan-cum-subsidy, Shramdan-cum-subsidy and Cash-cum-subsidy pattern of assistance. In case of loan-cum-subsidy, the

beneficiary share can be availed as loan amount from Nationalized Bank.

To avail the benefit of the schemes, the back end assistance is provided to the farmers for the following Components:

- ♦ Excavation of Ponds- Bonafide individual farmer with minimum 0.50 ha. of cultivable land/ Co-operative Farming Societies will be provided 50% of estimated cost or limited to Rs. 1,50,000/- per pond.
- ♦ Construction of RCC Ring well- Bonafide individual farmer irrespective of land holding/ Co-operative Farming Societies will be

- be provided 50% of estimated cost or limited to Rs. 1,00,000/- per well.
- ♦ Purchase of Pumpset (0.5 HP to 5.0 HP)- Bonafide individual farmers/ Co-operative farming societies irrespective of any land holding size. Subsidy will be provided for a minimum of 0.5 HP to maximum of 5.0 HP pumpset will be provided 50% of purchase cost or limited to Rs. 10,000/- per pumpset.
- ♦ Installation of Micro Irrigation System (Drip/ Sprinkler)- Bonafide individual farmer with minimum 0.05 ha. cultivable land/ Co-operative Farming Societies will be

provided 75% of system cost including Pumpset or Rs. 93,750/- per ha. whichever is less with 100% transport subsidy.

Documents to be Submitted are:

1. Filled application form in the prescribed format.
2. Latest copy of land record from CSC (in original) or attested by a Gazetted Officer / Revenue Officer.
3. Copy of Aadhaar Card.
4. Copy of bank details in favour of the farmer.
5. NOC from co-tenants (in case of joint property).
6. Mobile number linked with the applicant's bank account.

How to Apply:

Interested farmers have been requested to

contact the Agriculture Sub-Depot or Zonal Office in their respective areas to obtain the prescribed application form.

The filled-in application form along with the required documents are to be submitted to the respective Zonal Office for availing the Assistance under Scheme. Application forms for the subsidy are available at all Agricultural Sub Depot and Zonal Agricultural offices in the Islands.
