National Immunization Day for Polio to be observed in A&N Islands today

Children in the age group of 0-5 years to be administered Polio drops in 489 booths set up across Isles

Sri Vijaya Puram, Dec. 20

National Immunization Day (NID) for Polio will be held in A&N Islands on December 21, 2025, covering all the children in the age group of 0-5 years by administering two drops of bivalent Oral Polio Vaccine (OPV) in the Booths followed by house to house visits by the healthcare staff in the next two days to search and vaccinate the missed out / unimmunized



children.

This year, it is estimated that around

20666 children will receive the vaccine during the round in

489 booths set up across these Islands including booths in

Airport, Sea-port and other transit points.

All tourists and people having children in the age group of 0-5 years will also be covered under this program. Efforts are on to cover 100% of eligible children. The Director of Health Services has appealed to the general public to bring their children in the age group of 0-5 years to the booth for administration of Polio drops on Dec. 21, 2025, a press release from DHS said.

APPEAL

India's remarkable success in eliminating wild poliovirus, achieved in January 2011 and recognized by the World Health Organization through Polio-free certification in March 2014, stands as a landmark public health accomplishment. This hard-won achievement must be safeguarded through sustained vigilance and collective responsibility.

To ensure continued protection against any risk of re-introduction of the poliovirus, the National Immunization Day for Polio will be observed on 21st December, 2025, during which polio drops will be administered to all children in the 0-5 years age group.

I earnestly appeal to all sections of society-particularly members of Panchayati Raj Institutions, Non-Governmental Organizations, community leaders, and grassroots-level functionaries-to extend their fullest cooperation and actively participate in this vital endeavour. Let us work together to make the Intensive National Immunization Day for Polio on 21st December, 2025 a resounding success and reaffirm our unwavering commitment to safeguarding the health and future of our children, ensuring that India remains polio-free for generations to come.

Insurance coverage to farmers against crop losses due to natural calamities and unforeseen events under PMFBY

PMFBY notified for Rabi 2025-26 season

Sri Vijaya Puram, Dec. 20

The Pradhan Mantri Fasal Bima Yojana (PMFBY), a flagship scheme of the Government of India, is being implemented in

the Andaman & Nicobar Islands since 2016 to provide insurance coverage to farmers against crop losses due to natural calamities and unforeseen events.

PMFBY has been notified for implementation across the Andaman & Nicobar Islands for the Rabi 2025-26 season. Pulses and Vegetable crops have been

notified for insurance coverage. One cluster comprising South Andaman, North & Middle Andaman, and Nicobar (Campbell Bay area only) has been formed for implementation, with an indemnity level of 80% for all notified crops.


For the Rabi 2025-26 season, the scale of finance under the Pradhan Mantri Fasal

Bima Yojana (PMFBY) has been fixed at Rs.59,433 per hectare for Pulses, including Green Gram and Black Gram. For Vegetable crops, the scale of finance has been notified as Rs. 1,88,468 per hectare for Tomato, Rs.1,66,404 per hectare for Bhindi, Rs.1,24,419 per hectare for Lobia, Rs.1,72,742 per hectare for Brinjal, Rs.2,46,047 per hectare for

Cauliflower, and Rs.1,47,825 per hectare for Watermelon. The sum insured for each crop shall be calculated by multiplying the applicable scale of finance with the area insured under the scheme.

In a major relief to farmers, 100% premium subsidy will be provided during Rabi 2025-26, making PMFBY

completely free for both loanee and non-loanee farmers. The scheme covers losses from prevented sowing, sowing to harvest risks, post-harvest losses, localized calamities, and mid-season adversity.

All farmers, including sharecroppers and tenant farmers, growing notified crops in notified areas are eligible. The cut-off date for enrollment is 15.01.2026. Farmers may enroll through banks or self-register on the National Crop Insurance Portal (pmfby.gov.in).

Crop loss must be intimated within 72 hours to the implementing agency Kshema General Insurance Limited, the concerned bank, or the Agriculture Department. For assistance, farmers may contact the Kisan Call Centre: 243434 / 18003451145, a press release from Directorate of Agriculture said.


