Great Nicobar Airport:
Dual-Use Plan Unveiled

Govt plans dual-use green field airport at Great Nicobar for national security & tourism. Details on location, connectivity, & development plan

New Delhi, Dec 23

The central government has prepared an ambitious plan for the construction of a dual-use green field international airport at Great Nicobar that will play an important role in the country's national security and in promoting tourism.

According to the Detailed Project Report (DPR) prepared for the strategic airport, it will be developed as a dual-use military airfield with the control of the airside and Air Traffic Control with the Indian Navy and civil apron control and associated passenger-related facilities with the Airports Authority of India (AAI).

Great Nicobar is the southernmost and largest of the Nicobar Islands. Andaman and Nicobar Islands' main city, Sri Vijaya Puram, is located at a distance of more than 500 km from the island whereas international destinations like Phuket and part of the Sumatra islands are within a distance of 500 km from the proposed airport.

Apart from strategic needs, the airport will ensure ease of connectivity and hence present a great opportunity for tourism-oriented development that would put Andaman and Nicobar Islands on the map of global tourist destinations as well, according to the DPR.

The Indian mainland is at least 1500 km from this island, with cities like Delhi ranging at a distance of approximately 3000 km, while Calcutta and Mumbai are located at a distance of 1,850 and 2,250 km respectively. Singapore, Vietnam, Bali etc. are within a range of 1000 to 1500 km from the proposed airport.

The Great Nicobar island is situated at the foot of the Andaman and Nicobar

Hon'ble MP urges Hon'ble Civil Aviation Minister to facilitate air transport of day-old chicks to Islands

Sri Vijaya Puram, Dec. 23

Shri Bishnu Pada Ray, Hon'ble Member of Parliament from Andaman & Nicobar Islands, has taken up an issue affecting poultry farmers and egg supply in the Islands with the Hon'ble Union Minister for Civil Aviation, Shri K. Ram Mohan Naidu Ji.

In a formal representation, Shri Bishnu Pada Ray has urged the Civil Aviation Minister to direct all airlines operating on the Chennai - Sri Vijaya Puram sector to provide standardized facilities for the carriage of day-old chicks, as was available earlier, or to deploy specific flights equipped for this purpose. He emphasized that such an intervention would revive local egg production, protect farmers' livelihoods, generate employment, and enhance self-reliance in the poultry sector, a press release from MP Office said.

District Administration (SA) takes stringent action against illegal extraction and dumping of earth at Dollygunj & Hobdypur village

Sri Vijaya Puram, Dec. 23

The District Administration, South Andaman, continues its stringent drive against illegal extraction and transportation of minor minerals across the district. Acting on credible information, an inspection was conducted during which it was found that illegal extraction and dumping of earth had been carried out at Dollygunj and Hobdypur Village.

Acting on credible information, the Revenue field staff conducted inspections at Dollygunj and Hobdypur villages, during which instances of unauthorized extraction and dumping of earth were detected.

At Dollygunj Village, it was observed that land measuring 200 Sq. Mtr had been utilized for the illegal extraction and dumping of approximately 100 cubic metres of earth without obtaining prior permission from the competent authority. Based on the findings and after due examination, a penalty of Rs 70,000/- has been imposed, which includes the cost of the illegally extracted earth as well as the penalty pertaining to the seized excavator involved in the violation.

Further, at Hobdypur Village, the Revenue staff detected unauthorized dumping of approximately four truckloads of earth over an area measuring 170 square metres, classified as House Site land. In this case, a fine of Rs 32,000/- has been imposed on the violator for contravention of the prescribed rules.

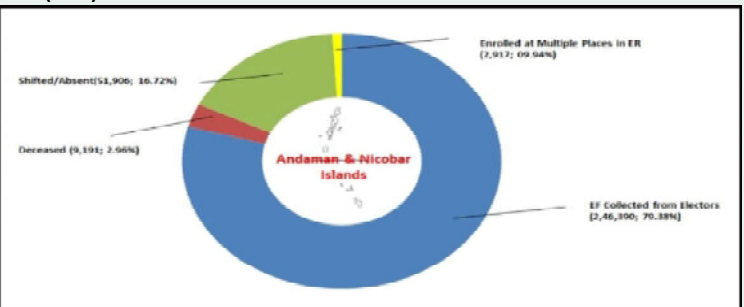
In total, a cumulative penalty of Rs 1,02,000/- has been imposed on both violators. The unauthorized extraction and dumping of earth constitute a violation of the provisions of the A & N Islands Minor Mineral Rules, 2012, and the Andaman & Nicobar

The Election Commission of India (ECI) is implementing the Special Intensive Revision (SIR) of the Electoral Rolls with reference to 01.01.2026 as the qualifying date in UT of Andaman & Nicobar Islands with clearly defined objectives to ensure maximum participation of electors, complete inclusion of eligible electors and full transparency at every stage of the process. The key objectives and activities undertaken under SIR are outlined below:

1. Participation of all Electors and All Political Parties



As on 23.12.2025, out of 3,10,404 electors, over 2,46,390 electors have submitted their Enumeration Forms, reflecting overwhelming participation in the first phase of SIR.

The successful completion of this phase is the result of coordinated efforts of DEOs of all 03 districts, 01 ERO, 12 AEROs, and BLOs deployed at 411 polling booths, supported by volunteers. Field representatives of all 4 major Political Parties, including their District Presidents, also actively participated with as many as 678 Booth Level Agents (BLAs) appointed by them. It is important to note that at the beginning of the SIR in this UT of Andaman & Nicobar Islands had only 435 BLAs. The increased number of BLA indicates active participation of the Political Parties and their representatives in this important exercise.

2. Ensuring No Eligible Elector is Left Behind

a. To ensure universal awareness and participation, during the enumeration period, CEO, DEOs, ERO and AEROs conducted extensive awareness campaigns and held multiple meetings with Political Parties to explain the process and shared updates on the progress of the enumeration phase of SIR at regular intervals.

b. BLOs also conducted meetings with Booth Level Agents to sensitise them as BLAs were permitted to file up to 50 Enumeration Forms per day to ensure their full involvement. BLOs visited homes of all electors listed on the rolls as of 27th October, 2025, to hand out these forms and followed up with at least three visits. BLAs and volunteers worked diligently to include every eligible voter.

As part of the Department of Administrative Reforms & Public Grievances (DARPG), Government of India initiative, the District Administration, South Andaman is observing the Good Governance Week (Sushasan Saptah) campaign 'Prashasan Gaon Ki Ore' from Dec. 19 to 25 in which multiple events focused on bringing governance closer to the people shall be organized.

As part of the campaign, grievance redressal camps were organized at Gram Panchayat Wandoor, Chouldhari Community Hall and Sippighat Hall, respectively, addressing public grievances and providing Government services at the door step of the citizen.

At Gram Panchayat Wandoor, the camp was held under the Chairmanship of Shri Kamaleshwar Rao S, IAS, Assistant Commissioner, South Andaman. 3. Special Initiatives Taken

- a. Special Camps were held in all Polling Booths to facilitate coverage of all electors.
- b. Help desks were setup at CEOs office, all DEOs office, all AEROs offices as well as at Polling Booths during Enumeration phase to facilitate electors to fill up the enumeration forms.
- c. 189 Volunteers and 132 additional manpower were also deployed to assist the electors in filling up the enumeration forms. BLOs were also supported by local Anganwadi workers and Asha workers to ensure speedy and accurate execution of work.
- d. Felicitation of BLO: Early completion of work was appreciated by felicitation of 48 BLOs from District and Tehsil level.
- e. Capacity Building: Repeat trainings, doubt clearing sessions, video tutorials to train our BLOs ensured high level of mapping.
- f. Common places with good internet connectivity were provided for BLOs of those parts where network facilities were not available, to enable digitization of Enumeration Forms (EFs) and ensure speedy completion of work.
- g. The parts located in remote islands, the DEOs/AEROs arranged special boats for BLOs to reach common places for digitization of EFs.

4. Inclusion of Young Electors

- a. Young electors who have attained or will attain 18 years of age on or before 01.01.2026 are being encouraged to apply through Form-6 along with the prescribed declaration.
 - b. Special campaigns will be conducted across Andaman & Nicobar Islands to enroll all eligible young electors.
 - 5. Engagement with Electors and Political Parties
- Booth-level lists of electors reported as deceased, permanently migrated or whose forms were not received were shared with the Booth Level Agents appointed by the Political Parties for verification.
- 6. Assistance by Election Staff and Volunteers

The entire election machinery, supported by volunteers, is assisting electors, particularly senior citizens, PwD electors and vulnerable groups. Special care has been taken by the DEOs, ERO, AEROs & BLOs to ensure that such categories of electors are facilitated.

7. Redressal of Issues During Enumeration

DEOs of all 03 districts in Andaman & Nicobar Islands have personally addressed every issue reported through Print, TV or social media to ensure that no grievance remains unattended.

8. Claims and Objections Phase: Scrutiny of Draft Electoral Roll

- 1. As per the SIR Order, the Draft Electoral Roll has been published on 23rd December 2025. Printed and digital Polling Booth wise copies have been provided to all recognized Political Parties and made available on the CEO's website: <https://ceoandaman.nic.in/>.
- 2. Polling Booth-wise lists of Absent/Shifted/Death/Duplicate electors whose names are not included in the Draft Roll, shall also be displayed on the Notice Board of respective Panchayat Bhavan/Urban local body office and Offices of the Block Development Officer/Panchayat Officers/Urban Local body officers to enable the general public to have access to the aforesaid voters lists along with the probable reasons for non-inclusion of their names and also these lists will be published on CEO's website (ceoandaman.nic.in) in an accessible format.
- 3. During the claims and objections period from 23.12.2025 to 22.01.2026, any elector or Political Party may file claims or objections for the inclusion of eligible electors or deletion of ineligible names. A total of 01 ERO and 16 AEROs are in position to scrutinize such cases.

9. No Deletion Without Due Process

- 1. As per Para 5(b) of SIR guidelines, no name can be deleted from the draft roll published on 23rd December, 2025 without notice and a speaking order by the ERO/ AERO. Any aggrieved elector may appeal to the District Magistrate and thereafter to the Chief Electoral Officer under Section 24 of the RP Act, 1950. Volunteers are also being trained to assist electors in filing appeals.
- 2. The Commission reiterates its firm commitment to a transparent, participative and inclusive revision process, ensuring that no eligible elector is left out and no ineligible name remains in the electoral rolls.

Islands and extends from Ranganatha Bay on the east coast to southwards to Galathea Bay and around the corner of Indira Point to Pemayya Bay.

The island of Sumatra is located barely at a distance of 180 km to the south of the Indira point which is also known as the southernmost tip of India.

The island covers a total area of approximately 910 sq km with the majority of the island designated as 'Great Nicobar Biosphere Reserve'.

The proposed site is located along the sea in between Gandhi Nagar and Shastri Nagar area on the South side of the Island. The site is accessible by a road connecting Galathea Bay to Campbell Bay at a distance of approximately 30 km from Campbell Bay.

The site is surrounded by hills and necessary site grading has been planned to facilitate safe aircraft operations. The flight path of the aircraft will run over the sea, and there will be minimal disturbance due to the overflying of aircraft at low altitude. The runway at this site is oriented in an approximate north/south direction which is suitable for the prevailing wind direction, according to the DPR.

The island's original inhabitants are the Shompen and Nicobarese tribes. The DPR also mentioned about the Great Nicobar Development Plan, which is a massive infrastructure plan envisaged by the government and includes a major transhipment port, airport and future strategic defence for the southern tip of Great Nicobar island.

According to this plan, 6,50,000 people are expected to inhabit the island by 2050. The current population of the island is only around 6,500.



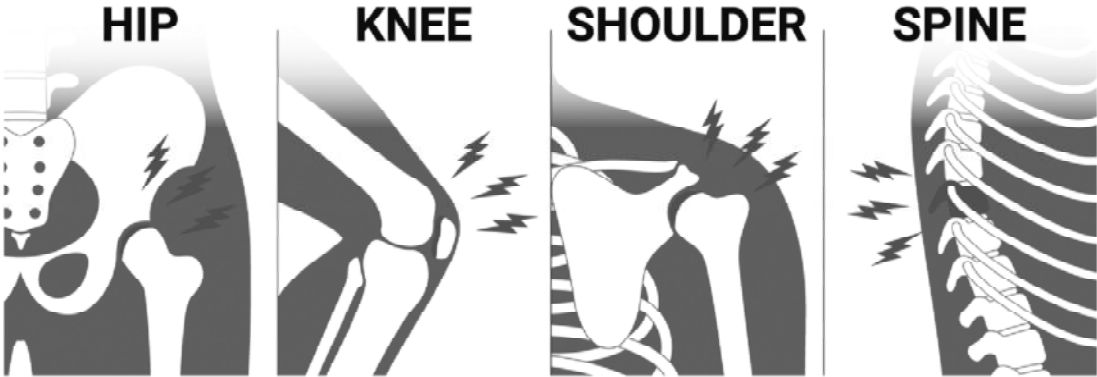
