Tuna Cluster notified under PMMSY in A&N Islands

Estimated potential yield of Oceanic Tuna & Neritic Tuna in Isles is 64,500 MT: Union Minister

New Delhi, Dec. 13 (PIB)

The Department of Fisheries (DoF), Ministry of Fisheries, Animal Husbandry & Dairying (MoFAH&D), Government of India (GoI) on 29.10.2024 has notified a Tuna Cluster in Andaman and Nicobar Islands under the Pradhan Mantri Matsya Sampada Yojana (PMMSY). The DoF, GoI, jointly with the Andaman & Nicobar Islands Administration organized an Investors' Meet on 14.11.2024 at Swaraj Dweep to showcase the investment opportunities in the field of Fisheries and Aquaculture Sector of the Andaman and Nicobar Islands.

The Marine Products Export Development Authority (MPEDA), Ministry of Commerce & Industry, informed that, in order to tap the untapped potential in

the Islands, they have prepared an action plan to promote direct seafood export from the Island territory in consultation with the stakeholders, addressing the existing gaps in the value chain. MPEDA has opened a Desk Office in Andaman & Nicobar Islands to facilitate fisheries trade from the Islands. The MPEDA has also identified a cluster of boats in the Islands for conducting onboard tuna handling training to fishers.

The Andaman and Nicobar Administration has informed that the Islands are rich in tuna biodiversity, with oceanic as well as neritic species including Yellowfin tuna, Skipjack tuna, and Bigeye tuna. The total estimated potential yield of Oceanic tuna and Neritic tuna in the Andaman and Nicobar Islands is 64,500 metric tonnes. The current

harvest is far below the potential, showing a significant untapped potential for growth in the sector.

The DoF, MoFAH&D, GoI has approved the proposals of Andaman & Nicobar Administration under PMMSY at a total cost of Rs.58.91 crore with central share of Rs.31.48

crore for development of fisheries including strengthening of infrastructure for tuna fisheries in the Andaman & Nicobar Islands. The major fisheries infrastructure activities approved under PMMSY include: (i) acquisition of deep-sea fishing vessels (7 unit), (ii) Up gradation of

existing fishing vessels for export competency (10 units), (iii) Cold storage and Ice Plants (29 units).

This information was given by the Minister of Fisheries, Animal Husbandry and Dairying, Shri Rajiv Ranjan Singh alias Lalan Singh, in a written reply in Rajya Sabha.

Rs. 210.87 Cr allocated for construction of roads under PMGSY and SFA in Isles: Minister

Sri Vijaya Puram, Dec. 13

Replying to an Unstarred Question raised by the Member of Parliament, A&N Islands, Shri Bishnu Pada Ray in Lok Sabha regarding roads in A&N Islands, the Minister of State in the Ministry of Home Affairs, Shri Nityanand Rai on 3.12.2024 informed that as per the inputs provided by the A&N Administration, the National Institute of Rural Development & Panchayati Raj

(NIRDPR), Hyderabad was engaged as Consultant, at a cost of Rs. 1.15 crore, for survey of roads under the schemes Pradhan Mantri Gram Sadak Yojana (PMGSY)-II and Special Financial Assistance (SFA). An amount of Rs. 210.87 crore has been allocated for construction of total 198 number of roads under the Schemes PMGSY and SFA, out of which construction of 100 number of roads has

been completed. The A&N Administration has identified 142 numbers of roads for improvement and 08 numbers of new roads for laying.

The Minister further informed that during the last five years, 128 numbers of new bituminous rural roads with a total length of 36.44 kms have been constructed by Panchayati Raj Institutions (PRIs), a press release from the MP Office said.

A&N Administration procured Bio-pesticides, Bio-fertilizer, seeds and other agricultural inputs as substitute for chemical fertilizers or pesticides: Minister

Replying to an Unstarred Question raised by the Member of Parliament, A&N Islands, Shri Bishnu Pada Ray in Lok Sabha regarding the ban on import of Neem Coated Urea, the Minister of State for Agriculture & Farmers Welfare, Shri Ram Nath Thakur on 10.12.2024 has informed that Andaman & Nicobar Administration vide Notification No. DA/PKVVY/18-1/LAC/2020-21/167 dated 21/01/2021, a uniform ban has been imposed on the

sale/use/entry/storage of all agro-chemicals for agricultural practices in Car Nicobar and Nancowrie group of Islands (Kamorta, Katchal, Teressa, Nancowrie & Chowra) with a broad vision to declare the above Islands as agro chemical free zone in order to ensure organic agricultural practices in Car Nicobar and Nancowrie group of Islands.

The Minister further informed that as a substitute of chemical fertilizers or pesticides, the Andaman &

Nicobar Administration has procured Bio-pesticides, Bio-fertilizer, seeds and other agricultural inputs. During the current financial year, 903 kgs of bio-fertilizers, 1619 kgs of Bio-Pesticide and 65 MT of Rock Phosphate has been procured and allotted for sale to the farmers. Further, for promotion of organic farming, from 2015-16 to 2024-25, 135 training programmes, 485 demonstrations and 1936 campaigns for

95 CSCs are functional in A&N Islands: Minister

Replying to an Unstarred Question raised by the Member of Parliament, A&N Islands, Shri Bishnu Pada Ray in Lok Sabha regarding creation of a separate Directorate of Information Technology in A&N Islands, the Minister of State for Electronics and Information Technology, Shri Jitin Prasada informed on 11.12.2024 that creation of Directorate of Information Technology catering to a State or

Union Territory comes under the purview of concerned State/UT Administration. In line with Hon'ble Prime Minister's vision to democratize use of technology, Ministry of Electronics and Information Technology has taken various initiatives for Andaman & Nicobar.

The Minister said, Common Services Centres (CSCs) have been set up to deliver e-services including Government services, financial services and

services related to Aadhaar, various social welfare schemes, education, telemedicine, travel bookings, utility payments, etc. 95 CSCs are functional in Andaman & Nicobar, out of which, 71 CSCs are functional at GP level.

The Minister further informed that DigiLocker has provided a platform to the citizens for issuance and verification of digital documents and certificates. Department of Civil Supplies &

Meeting to address all issues related to manufacture, storage, transportation & retail sale of packaged drinking water in Isles held

Testing of Packaged Drinking water through NABL accredited & FSSAI notified laboratories mandatory

Sri Vijaya Puram, Dec. 13

A meeting was held in the conference hall of DC Office, South Andaman District under the chairmanship of Joint Commissioner (Food Safety), A&N Islands/ Additional District Magistrate, South Andaman today. The meeting was held to address all the issues related to manufacture, storage, transportation and retail sale of packaged drinking water in these Islands. The Joint Commissioner (Food Safety) informed that recently the Food Safety and Standard Authority of India has lifted Bureau of Indian Standards mandating of packaged drinking water and categorized it as High Risk



category. Henceforth, testing of Packaged Drinking water through NABL accredited and FSSAI notified laboratories would be mandatory.

The Joint Commissioner warned all Packaged Drinking Water manufacturers to refrain from mislabelling and filling 20lts cans of other manufacturers. Such practices are offence (sale of misbranded product) under FSS Act which is

punishable u/s 52 of the Act with a fine which may extend upto Rs. 3 Lakhs.

The Joint Commissioner (Food Safety) reiterated that since water is an essential commodity, hence all the manufacturers of packaged drinking water/ purified drinking water must follow all the guidelines and follow fair trade practices, a press release from Designated Officer (FS), SA said.

Mangrove Walkway connecting Dinghy Ghat with beach of Shoal Bay-19 inaugurated

Walkway constructed using timber & wooden posts to maintain green profile of serene landscape

The Principal Chief Conservator of Forests, Andaman & Nicobar Islands, Shri Sanjay Kumar Sinha, IFS, Principal Chief Conservator of Forests, Andaman & Nicobar Islands, inaugurated the newly constructed Mangrove Walkway at Shoal Bay-19 under the Mannarghat Range of South Andaman Forest Division today in the presence of senior officers of the Forest Department, Gram Pradhan, Samiti member and other local PRI members.

The 450 meters long and 1.2 meters wide Mangrove Walkway connects Shoal Bay-19 Dinghy Ghat with the



beach of Shoal Bay-19. The entire walkway has been constructed using timber and wooden posts thereby maintaining the green profile of the serene landscape. Well placed eco-huts made from naturally available materials such as thatching leaves, teak posts, rattans, Jungli ballies, bamboo etc. are

also there on the 450 meter long walkway to provide resting areas for the visitors.

The Mangrove walkway was constructed by South Andaman Forest Division under the Scheme: Eco-tourism. Earlier, the beach was not accessible by walk and visitors were using locally available



dinghies to reach the Shoal Bay-19 beach which was cumbersome. Other necessary infrastructures have also been developed to boost the eco-tourism potential of this natural paradise. Many commercial activities would also get a push by development of infrastructure and

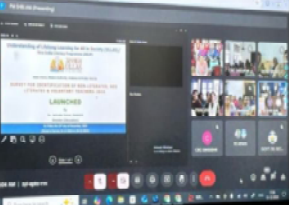
