Sri Vijaya Puram, Dec. 18 The 43rd India-Indonesia Coordinated Patro1 (IND-INDO CORPAT) commenced on Dec.10, 2024 at Sabang Port, Indonesia, marking a significant milestone in bilateral maritime cooperation. The Opening Ceremony featured the arrival of Indian Naval Ships INS Kesari and LCU 57, which were warmly received dynamic joint exercises in a traditional manner by the Commander Maritime Security Task Force Dornier, and Indonesian Indonesia (CO MSTFI). IN ships remained at Sabang from Dec. 10-12, 2024, while Indonesian (IDN) Units

visited Sri Vijaya Puram from Dec. 16-18, 2024 for the harbour phase. This phase involved the reception of IN Units at Sabang and IDN Units at Sri Vijaya Puram, followed by official calls and the closing ceremony. WHEREAS, it has been reported by the Executive Engineer, APWD, Construction Division, Diglipur, vide Letter No. RR-DB/CD/DP/2024-25/5220 dated 14.12.2024, that the Steel Bailey Bridge located on State Highway-14 (SH-14) at Nabagram (Chainage 3.118 Km from Kalara Tri-Junction) is damaged and in an unsafe condition due to cracks in some of its beams (transoms). which requires immediate repair;

AND, WHEREAS, Steel Bailey Bridge located on State Highway-14 (SH-14) at Nabagram is the only connectivity to Kalighat and Ramnagar area;

AND, WHEREAS, it has been brought to the notice of the undersigned that despite warning boards, heavy loaded vehicles are plying on the road which can cause danger to human life and safety of the passengers;

AND, WHEREAS, the Executive Engineer, CD, APWD, Diglipur has informed the undersigned vide Letter No. RR-DB/CD/DP/2024-25/5220 dated 14.12.2024 that repairing work of that Bailey bridge shall be undertaken on 19th December, 2024;

NOW, THEREFORE, I, Kamaleshwar Rao S, IAS Sub-Divisional Magistrate, Diglipur, in exercise of the powers conferred on me under Section 163 of BNSS, 2023, do hereby order the closure of the road passing through the Bailey Bridge on SH-14 at Nabagram on 19.12.2024 for a period of one day and prohibit any individual residing in Nabagram Village and the general public from using the Bailey Bridge on SH-14 at Nabagram in the interest of public safety and to facilitate immediate repair work.

AND, ALSO, during this closure, no vehicular movement, except emergency vehicles, shall be permitted over the said bridge.

The Executive Engineer, APWD, Diglipur, is directed to ensure the repair work is completed within the stipulated period and communicate its reopening promptly.

The Deputy Superintendent of Police. Diglipur is hereby enjoined upon to ensure compliance of this Order.
