The Union Cabinet chaired by the Hon'ble Prime Minister, Shri Narendra Modi passed a Condolence Resolution in the memory of Dr. Manmohan Singh, Former Prime Minister. The Cabinet paid homage to Dr. Manmohan Singh by observing a two-minute silence. State mourning has been declared for seven days till 01.01.2025.

During this mourning period, the National Flag will be flown half-mast throughout Bharat. The National Flag will also be flown at half-mast in all the Indian Missions/High Commissions abroad for seven days till 01.01.2025. Dr. Manmohan Singh will be accorded a State Funeral tomorrow morning (Dec. 28).

On the day of State Funeral, a half day holiday has been declared for all the Central Government Offices and CPSUs.

ANPCC urges general public & industrial stakeholders to responsibly manage and dispose of waste generated in domestic and industrial setups

Sri Vijaya Puram, Dec. 27

The Andaman and Nicobar Pollution Control Committee (ANPCC), Department of Science and Technology, Andaman and Nicobar Administration has urged the general public and industrial stakeholders to responsibly manage and dispose of waste generated in domestic and industrial setups in accordance with the Municipal Solid Waste Management Rules, 2016. Effective waste management is critical to maintaining the pristine environment of the Andaman and Nicobar Islands and ensuring the health and well-being of the

community.

For domestic setups, residents have been requested to segregate waste at the source and hand over to the Municipal authorities for proper processing and disposal. Industries operating in the region have been mandated to follow best practices for waste management by implementing waste segregation, recycling and safe disposal protocols. All industrial units must

ensure compliance with environmental regulations, including obtaining necessary consents from ANPCC for waste generation and treatment. Hazardous industrial waste should be disposed of through authorized agencies and untreated waste water must not be discharged into the environment. Industries have also been encouraged to adopt cleaner technologies and reduce waste

generation at the source.

The public have been urged to avoid open dumping and burning of waste, as these practices can lead to air, water and soil pollution.

In light of the growing concern regarding cigarette and bidi butt litter, ANPCC also highlights the importance of their proper disposal. Cigarette and bidi butts, though small in size, pose a significant

environmental threat due to their non-biodegradable components and toxic chemicals. Local authorities have been requested to include the provisions in Municipal Bye-laws to prohibit smoking in public areas and workplaces and to impose fines for littering cigarette butts. Commercial

Lt. Governor revises Minimum Rates of Wages across 6 Schedules of Employment Revised rates of Minimum Wages to come into effect from Jan. 1

The Lieutenant Governor, Andaman & Nicobar Islands has revised the Minimum Rates of Wages across 6 Schedules of Employments in addition to Govt. Departments/Offices/Industrial Establishments as mandated under the provisions of Minimum Wages Act, 1948 in the UT of A&N Islands w.e.f. 1st January, 2025. The

Revised Rates of Minimum Wages are as under:-

Category of employee	Minimum wage per day
Unskilled	Rs. 641.00
Semi-Skilled/Unskilled Supervisory	Rs. 722.00
Skilled/Clerical	Rs. 845.00
Highly Skilled	Rs. 928.00

An order copy of revised rates of minimum wages may be downloaded from www.labour.and.nic.in.

All employers of the establishments have been requested to comply with the revised rates, failing which, punitive action as per the provisions of Minimum Wages, 1948 and its Rules made thereunder shall be initiated, a press release from Labour Department said.

Regional Training Camp for National Sample Survey gets underway

National Statistics Office under the Ministry of Statistics and Programme Implementation, Govt. of India is organizing a Regional Training Camp for National Sample Survey 80th Round from 26th to 30th Dec.2024 at Kendriya Sadan, CPWD Complex, Lamba Line, Sri Vijaya Puram. Shri Gaurang Mishra, Director, Directorate of Economics & Statistics, A&N administration inaugurated the Regional Training Camp. In his address, he highlighted the need for high-quality data and urged the participants to ensure rigorous standards in

data collection. Shri Bappa Saha, Assistant Director, NSO is conducting the training camp.

During the camp, necessary training will be imparted to the officials to carry out the survey which is scheduled to be launched in January 2025. This round of survey is earmarked for Survey on Health and Comprehensive Modular Survey on Telecom.

The survey on health aims to generate basic quantitative information on the health sector. Primarily, indicators on morbidity, hospitalization rates, utilization of both

public and private health care institutions, proportion of institutional childbirth etc. will be attempted to be derived from this survey data.

The Comprehensive Modular Survey (CMS) on Telecom will provide information on telecom related indicators and ICT skills. The collected data will also be used for reporting of global indices by line Ministries / Departments. The Survey will cover the whole of Andaman and Nicobar Islands, a press release from National Statistics Office said.
