New Delhi, Feb. 16 (PIB)

The President of India, Smt. Droupadi Murmu inaugurated the National Tribal Festival 'Aadi Mahotsav' in New Delhi today. Speaking on the occasion, the President said that Aadi Mahotsav is a key event to highlight and promote tribal heritage. Such festivals provide a great opportunity for the entrepreneurs, artisans, and artists of the tribal society to connect with the market.

The President said that the crafts, food, dress and jewellery, medical practices, household equipment, and sports of the tribal society are the precious heritage of our country. At the same time, they are also modern and scientific because they show a natural harmony with nature and the ideals of a sustainable lifestyle.

The President said that during the last 10 years, many effective steps have been taken for the overall development of the tribal



society. The Tribal Development Budget has increased five times to about one lakh twenty-five thousand crore rupees. Apart from this, the Tribal Welfare Budget Allocation has increased three times to about 15 thousand crore rupees. The idea behind paying special attention to the development of tribal society is that only when the tribal society progresses, our country will also

progress in the true sense. That is why, along with increasing the sense of pride toward tribal identity, multi-dimensional efforts are being made to develop the tribal society at a fast pace.

The President was happy to note that a lot of progress is being made towards the economic empowerment and employment of the tribal society. She highlighted that education plays the most important role in the development

of any society. She said that it is a matter of happiness that about 1.25 lakh tribal children are getting school education through more than 470 Eklavya Model Residential Schools in the country. In the last 10 years, 30 new medical colleges have been started in tribal-dominated areas. A national mission has been launched to solve a specific problem related to the health of the tribal society. Under this mission, the target has been set to eradicate sickle cell anemia by the year 2047.

Aadi Mahotsav is being organised by the Ministry of Tribal Affairs from February 16 to 24, 2025 at Major Dhyani Chand National Stadium, New Delhi. This festival aims to provide a glimpse into the rich and diverse traditional culture of the tribal communities of our country.

- > Category (VI) - Digital transformation by Use of Data Analytics in Digital Platforms by Central Ministries/States/UTs. In this category, 1 award would be conferred.

National Lok Adalat on March 8

The District Legal Services Authority, Andaman & Nicobar Islands will be holding National Lok Adalat in the District Court Complex at Port Blair and Sub-Divisional Court Complex at Mayabunder and Circuit Court at Diglipur on 08.03.2025. Besides the compoundable nature of cases pending in different Courts, disputes at the pre-litigation stage will

also be entertained by the National Lok Adalat for disposal upon consensual settlement between the parties. Pre-litigation disputes include (i) NI Act cases u/s 138, (ii) Money recovery cases, (iii) Labour dispute cases, (iv) Electricity and water bills cases (excluding non-compoundable), (v) Maintenance cases (vi) Civil disputes and (vii) Disputes under the Consumer Protection Act.

The public in general having any such dispute at the pre-litigation stage or post-litigation stage are at liberty to submit their disputes in writing to the Secretary, District Legal Services Authority, Port Blair before Feb.27, 2025, so that their disputes may be processed and made ready for hearing before the National Lok Adalat on March 8, 2025, a press release from DLSA said.

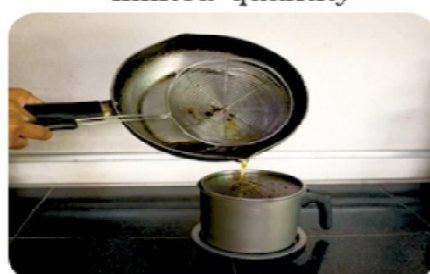

farming practices, and advanced livestock management solutions. Special emphasis is being placed on integrated farming systems, disease-resistant livestock breed, feed and fodder management, and value addition of local agri-produce. This initiative aims to accelerate the adoption of cutting-edge technologies by local farmers and livestock owners, ensuring higher productivity and sustainability.

A meeting was organized between ICAR-CIARI, KVK, Department of Agriculture and Animal Husbandry & Veterinary Services in the mini-conference hall of the Secretariat of A&N Administration recently, which was chaired by Smti Pallavi Sarkar, IAS, Secretary (Agri/AH). Discussions during the meeting centered around scaling up successful interventions, addressing challenges faced in technology adoption, and enhancing farmer-scientist interactions through regular workshops and on-field demonstrations.
