## A&N Administration invites tenders for research stations at Great Nicobar sites

New Delhi: The Andaman and Nicobar Administration has started inviting tenders for infrastructure associated with the Great Nicobar mega infrastructure project. On February 3, the Andaman Public Works Department invited bids for setting up of "research stations for GNI project".

Separately, the Andaman and Nicobar Islands Integrated Development Corporation Limited (ANIIDCO), the company executing the project, has invited applications to engage experts as consultants to assist ANIIDCO/Andaman



and Nicobar Administration in pursuing various infrastructure projects. These consultants include urban planner; infrastructure specialist and also a legal expert with experience in legal advisory for real estate, township development,

among others. In October, the National Thermal Power Corporation (NTPC) issued a detailed expression of interest to install power infrastructure at Great Nicobar Island. The last date of submission of bids was November 8, 2024. HT reported on September 28, 2024

that ANIIDCO has begun the process for the selection of contractors to carry out "enumeration, felling, logging, and transportation" of trees as part of the Great Nicobar development project. HT reported on February 4 that various wildlife and biodiversity research

organisations had submitted research proposals for monitoring of impact from the Great Nicobar project. The Wildlife Institute of India (WII) for example, has submitted a research proposal on a conservation plan for three important species, Leatherback Sea Turtle, Nicobar Megapode, and Saltwater Crocodile; and the Salim Ali Centre for Ornithology and Natural History on a biodiversity management plan and bird hazard risk assessment study for the proposed international airport. ## Union Health Ministry launches Intensified Special NCD Screening Drive to ensure 100% coverage of all individuals aged 30 years and above

New Delhi, Feb. 20 (PIB)

In view of the escalating burden of Non-Communicable Diseases (NCDs) in the country, the Ministry of Health & Family Welfare has launched an Intensified Special NCD Screening Campaign today. Running from 20<sup>th</sup> February to 31<sup>st</sup> March, 2025, this ambitious initiative aims to achieve 100% screening of all individuals aged 30 years and above for prevalent NCDs, including Diabetes, Hypertension, and three common cancers-Oral, Breast, and Cervical. The campaign will be executed across Ayushman Arogya Mandirs (AAMs) and various healthcare facilities nationwide, under



the National Programme for Prevention and Control of Non-Communicable Diseases (NP-NCD). **Key Highlights of the Campaign are as under:**  
**Door-to-Door Outreach:** Trained ASHAs, ANMs, and

## MP calls for urgent repair of damaged Sluice Gate at Garacharma Village

Sri Vijaya Puram, Feb. 20 Shri Bishnu Pada Ray, Hon'ble Member of Parliament, has drawn attention to the long-pending issue of the damaged sluice gate near the Solar Power Plant at Garacharma Village, Attam Pahad in South Andaman. The sluice gate was originally constructed to prevent seawater intrusion into public and private lands. Unfortunately, it sustained major

damage due to the Tsunami -2024 and subsequent earthquake, leading to continuous seawater ingress, which has left the lands of recorded tenants submerged and unsuitable for development. Shri Bishnu Pada Ray has earnestly requested the Chief Secretary of the Andaman & Nicobar Administration to kindly intervene and direct the APWD

authorities to prioritize the repair and reconstruction of the sluice gate. Restoring the structure will not only safeguard the lands from further damage but also open up opportunities for the development of a residential colony with the potential to accommodate over 2,000 plots, thereby benefiting a large number of affected families, a press release from MP Office said.
