officials/staff of RCS & Education, 40 representatives/teams from resource Departments and 25 Civil Defence/Aapda Mitra Volunteers of South Andaman. In accordance with the drill scenario, the Department's incident commander quickly sent out teams to warn all employees to evacuate safely after learning of an earthquake. They also notified the appropriate resource Departments (SEOC, DEOC (S/A), Fire, Police, Electricity, NDRF& Health) for support and assistance. The Department personnel effectively conducted safe evacuation and search and rescue operations. Ambulances and fire engines quickly arrived at the simulated location to rescue and treat the injured. The teams of Resource Departments carried out Search & Rescue and provided First Aid to the victims of the mock drill.

At 11.30 am, the mock drill came to an end with a debriefing session, where the Observers briefed their observations and pointed out areas that needed work. 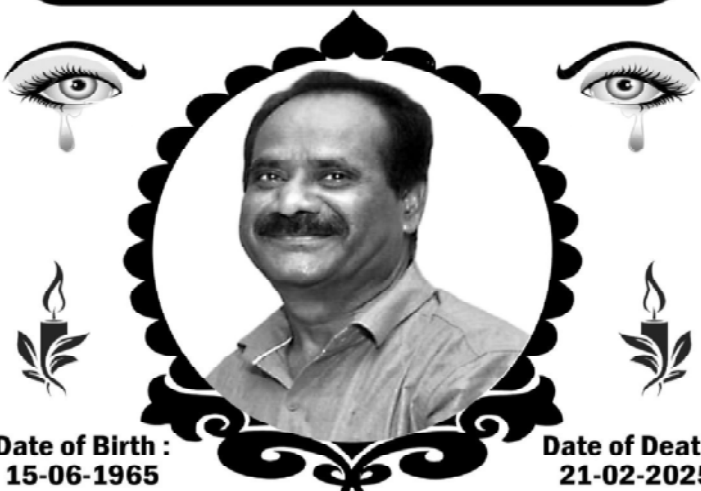
