

has said that over four Sukanya crore Samriddhi accounts have been opened across the country. The scheme was launched on 22<sup>nd</sup> January, 2015 as part of the Beti Bachao, Beti Padhao campaign. scheme allows parents to open a Sukanya Samriddhi account for girls at any Post Office designated commercial bank branch, starting with a minimum initial deposit of 250 rupees.

## **Traffic arrangements notified in connection** with Full Dress Rehearsal on Jan. 24 and Republic Day Function on Jan.26

Sri Vijaya Puram, Jan. 21

The general public have been informed that the following Traffic arrangements have been made in connection with Full Dress Rehearsal on 24th January, 2025 and Republic Day Function on 26th January, 2025.

- > The carcade of the Hon'ble Lt. Governor, Andaman and Nicobar Islands, will follow the route Fire Brigade Crossing→ Vikas Bhawan→ Scout Hut Junction→ Y Narayan Junction, and arrive at Cellular Jail. After the wreath-laying ceremony at the Cellular Jail Martyrs' Column, the carcade will proceed to the venue via the route; Cellular Jail→ Water Sports Tri-Junction→ Marina Park. The Hon'ble Lt. Governor's carcade will be parked inside Marina Park near the designated alighting point.
- Senior Administrative Officers holding the 'P' (Green) parking card may take any route to reach the venue. The dignitaries should alight at the designated drop-off point inside Marina Park. After dropping off the officers/dignitaries, the vehicles must proceed to the designated 'Green P' parking areas. These parking areas are located either near the entrance gate of Marina Park (Children's Traffic Park) or near Dugong Guest House. To reach these parking zones, vehicles should follow the route; Girls School Junction→ Scout Hut Junction→Netaji Stadium→Y Narayan Junction→Parking near Dugong Guest House or Parking near Marina Park Gate (Children's Traffic Park).
- > Officers holding the 'P' (Pink) parking card may take any route to reach the venue. The dignitaries should alight at the designated drop-off point inside Marina Park. After dropping off the officers/dignitaries, the vehicles must proceed to the designated 'Pink P' parking areas. These parking areas are located near the Swimming Pool Complex. To reach these parking zones, vehicles should follow the route; Girls School Junction→ Scout Hut Junction→Netaji Stadium → Swimming Pool Parking Area.
- The holders of all 'P' (Green and Pink) car parking label except the Hon'ble LG's carcade, may use the routes:
  - a. Clock Tower Y Narayan Junction Dharamsala Junction -Marina Park gate (Children's Traffic Park).
  - b. APWD Junction-Fire Brigade Junction-Scout Hut Junction-Netaji Stadium - Y-Narayan Junction - Dharamsala Junction - Marina Park Gate (Children's Traffic Park).
- Holders of the 'P-1' car parking label should use the following route: Clock Tower→Y Narayan Junction→Netaji Stadium. Parking is available inside the Netaji Stadium behind SAI Hostel.
- > The Holders of the 'P-1' car parking labels will be seated on the right side (Swimming Pool end), opposite the Chief Guest's main dais. They are requested to arrive at the venue not later than 0735 hrs using the route beside the swimming
- After the carcade of the Hon'ble Lt. Governor departs from the venue, vehicles with the 'P' (Green and Pink) parking label should proceed to the alighting point inside Marina Park. From there, they will exit towards Girls School and follow the route; Girls School Junction→Scout Hut Junction→ Vikas Bhavan (ANIIDCO Office)→Fire Brigade→APWD Crossing, and then continue to their respective destinations.
- > After the carcade of the Hon'ble Lt. Governor departs from the venue followed by departure of vehicles with "P" (Green and Pink) parking labels, vehicles with the 'P-1' parking label shall depart following the route; Parking near Sports Hostel→Netaji Stadium→Y Narayan Junction→Clock Tower, and then proceed to their respective destinations.
- ➤ The general public without invitation cards, arriving in vehicles without a parking label (including two-wheelers and four-wheelers), must park inside the students' athletic Shri Wilfred Rich In-Charge of the Netaji Stadium behind Multipurpose Hall. They are requested to arrive at the venue not later than 0700 hrs using the main entrance gate of Netaji Stadium and then proceed towards the gate leading to the Multipurpose Hall.
- > After the function concludes, vehicles without parking labels, parked in Netaji Stadium, will be directed from the parking area towards Y Narayan Junction or Clock Tower to proceed to their respective destinations, but only after all vehicles with valid parking passes have been cleared.
- > From 0800 hrs to 1030 hrs, vehicles traveling between Aberdeen Bazaar and South Point (in either direction) will be diverted via the following route; Model School Crossing→APWD Crossing→Murugan Temple→Siddiqui Junction →Shadipur Junction.
- From 0730 hrs to 1030 hrs or until the parade and invitees have dispersed, heavy vehicles and buses heading towards Model School/Clock Tower will be diverted at Bengali Club to proceed via Goalghar and Junglighat.
- > From 0800 hrs until the dispersal of the parade and invitees, no vehicles will be allowed to proceed towards the venue via the following routes; Cellular Jail→Y Narayan Junction→Fire Brigade Junction→Murugan Temple→RK Mission→Flag Point→Water Sports Tri-Junction.
- > From 0600 hrs until the completion of the function, no vehicle will be allowed to proceed towards Girls School from the following points; Scout Hut Junction→RK Mission →Machi Line→Govt. Press→Hotel Sinclairs/Circuit
- > Ambulances and vehicles carrying medical emergency cases heading to GB Pant Hospital should follow the route; Y Narayan Junction→Cellular Jail →GB Pant Hospital. This route will remain closed to all other vehicles from 0805 hrs to 0835 hrs, except for ambulances and vehicles with medical emergencies. Further, vehicles stationed inside GB Pant Hospital will be allowed to proceed towards the back gate of the GB Pant Hospital and will be diverted towards Dignabad Seashore Road via Water Sports Tri-Junction from 0700 hrs to 1000
- > Vehicles carrying parade contingents, after dropping the contingents at Girls School Junction, should proceed towards Fire Brigade and remain stationed there. After the parade culminates at Fire Brigade Junction, these vehicles will return to their respective units with the parade contingents.
- The marching contingents participating in the Republic Day Parade will march from Girls School Crossing towards Dharmshala Crossing, and then follow the route; Y Narayan Junction→Clock Tower→Model School Crossing, culminating in front of Fire Brigade Crossing.
- > The tableaux participating in the Republic Day Parade will drive from Girls School Crossing towards Dharmshala Crossing, and then follow the route: Dugong Guest House→Water Sports Tri-Junction and finally halt at Foreshore Road, a press release from DM, SA said.

#### The terms and conditions of the e-Auction are given below: -

- 1. Each prospective bidder shall be required to deposit an earnest money, which shall be 5% of the Minimum Reserve Price for the quarry area with the Deputy Commissioner, South Andaman before participating in the e-auction (drawn in favour of Assistant Commissioner, Settlement).
- 2. The earnest money should reach to the Cashier, Office of the Assistant Commissioner, Settlement on or before 17.02.2025 at 1700 hours.
- 3. The EMD should be in the form of A/C Payee Demand Draft/FDR/Bankers Cheque or Bank Guarantee from any of the Commercial bank drawn in favour of the Assistant Commissioner, Settlement and should be uploaded in http://eauction.gov.in. No prospective bidder shall be allowed to participate in the e-auction process if EMD is not deposited within stipulated time in the office.
- 4. The earnest money deposited, except in case of declared highest bidder, shall be refunded to other bidders after the completion of the e-auction unless forfeited by the Deputy Commissioner/ Presiding Officer for reasons to be recorded in writing. In case of the declared highest bidder, however, the earnest money will be adjusted against the highest bid amount to be deposited within the period specified in the award letter i.e. before execution of lease deed. In the event of failure to do so, the earnest money and the security amount shall be forfeited and the quarry area may be assigned to the next highest bidder at declared highest bid.
- 5. The Minimum Reserve Price has been fixed as Rs.42.8 Lakhs (Rupees Forty-Two Lakhs Eighty Thousand-Only) for Explosive quarry for quarry block of 0.25 hectares and Rs.26.3 Lakhs (Rupees Twenty Six Lakhs Thirty Thousand-Only) for Non-explosive quarry block of 0.2050 hectares for 01(One) year for 12000 cbm.
- 6. Any quarry areas can be withdrawn from the e-auction without assigning any reason thereof.
- Only one quarry lease shall be permitted to a successful bidder in the District.
- 8. No sub-lease/sublet or any types of agreement of the quarry shall be permitted.
- No bid which is below the minimum reserve price fixed for the quarry area shall be accepted.
- 10. The period of lease shall be only for **01(One) year** from the date of executing the lease deed.
- 11. No person shall be entitled to participate in the e-auction unless he furnishes:
- a. An affidavit sworn before any Executive Magistrate/Notary Public to the effect that no amount of contract money, royalty in respect of any quarry lease/permit held by him earlier is outstanding against him/her.

#### NOTE: The document is to be submitted along with the Earnest Money Deposit.

- 12. The prospective bidder shall produce proof of submission of EMD and the documents as above at the e-auction site (http://eauction.gov.in) prior to commencement of e-auction process. He/ She shall upload identity proof to establish his/her identity in the e-auction site (http://eauction.gov.in) failing which he/she shall not be allowed to take part in the e-auction.
- 13. The Deputy Commissioner (SA) may direct the bidders at the end of e-auction to produce the amount considered reasonable by him or a bank instrument of such amount in case he feels that the amount of bid has gone unreasonably high and there is a possibility of the bidders trying to skip away or refuse to deposit the due bid amount as per terms and conditions of the e-auction notice.
- 14. The highest bid received in the e-auction shall become a successful bid only after the approval of the Competent Authority.
- 15. The Successful bidder shall be liable to deposit 25% of his bid amount as security of the highest bid with the Deputy Commissioner (SA) on acceptance of bid in the form of FDR/ Bankers Cheque from any of the commercial banks drawn in favour of Assistant Commissioner, Settlement immediately after receipt of acceptance.
- 16. The lessee shall pay 5% of the bid amount as performance security in the form of A/c Payee Demand Draft, FDR, Bankers Cheque or Bank Guarantee from any of the commercial banks, which shall remain valid for a period of 60 days beyond the expiry of the lease deed and subject to compliance of other terms and conditions of the lease deed/quarry plan, which shall be released after the expiry of all contractual obligations. In the event of any breach of contract and conditions laid down in the lease agreement, quarry plan and Environment Clearance granted by the competent authority, the performance security shall be forfeited to the Government.
- 17. The prospective bidder has to submit necessary copies of documents duly self-attested viz. quarry lease deed and (or) Consent to Operate (CTO)/ consent to establish (CTE) issued by any State/UT Govt. or other Govt. agencies of two (2) years in quarrying and (or) crushing activities from the year beginning 2012 to till date. The prospective bidders have to submit an affidavit duly sworn before the Executive Magistrate/Notary Public stating that the prospective bidders have the capabilities with respect to personnel, equipment's/ machineries and manufacturing facilities in handling of quarrying and crushing units in compliance to the rules and regulation in force. The prospective bidders have an average annual financial turnover of Rs.56.00 Lakhs during the last three years ending 31st March-2024 (balance sheet and profit & loss account of last three years ending 31st March-2024). The prospective bidders also submit IT returns of last three years for the said period.
- 18. The successful bidder shall have to execute quarry lease deed before execution of quarry operation.
- The saccessful blader shall have to execute quarry lease deed before executing the lease deed.
- 20. The lease holder shall be liable to pay advance income tax as per provisions of section 206(c) of income tax act in addition to bid amount, payable as per terms and condition of contract agreement before submission of royalty.
- 21. The lease holder shall be liable to pay the rent for the quarry area, royalty as notified from time to time.
- 22. The lease holder shall be liable to pay the GST as admissible from time to time on royalty paid, to GST Commissionarate and quarterly report to this effect shall be submitted to the competent authority along with supplementary documents specifically showing GST paid for the royalty of stone boulders.
- 23. The lease holder shall have stacking place for proper storage of quarry products in such a way that measurement would be taken if required.
- 24. The lease holder shall undertake the quarrying in the quarry area in terms of the quarry plan notified and in accordance with the responsibilities as laid down under Rule 13 of the A & N Islands Minor Minerals Rules, 2012.
- 25. No lease holder shall be entitled to raise any dispute with the reference to the survey and demarcation of the quarry permitted out to him after execution of the quarry lease deed.
- 26. The lease holder shall be permitted to extract maximum of 12000 cbm of minor mineral during 01(One)year from the Quarry area leased out to him and he/she is expected to satisfy himself of the availability of minor mineral to this extent prior to participating in the e-auction. It is reiterated that it is for the prospective bidders to do the estimation with regard to the potential of quarry site prior to the bidding which shall be the sole responsibility of prospective bidders.
- 27. The lease holder shall remit the royalty of Minimum 1/4th of the allotted quantity during the first month of every quarter irrespective of extraction of stone aggregate/boulder.
- 28. **Site inspection may be** carried out by the prospective bidders for physical verification of the site of his/her interest. The quarry sites as shown in the annexure are easily identifiable on the field. However, assistance may be obtained from the district office, if required.
- 29. NO quarrying shall be permitted in a depression or below mean sea level.
- 30. Quarrying operation should not involve destruction of any tree and also should not violate other prohibited areas norms.
- 31. That the lease holder shall abide by the provisions of the Mines and Minerals (Regulation and development) Act, 1957, A & N Islands Minor Minerals Rules, 2012 and the Rules and Regulations regarding Employment and Conditions of Service as for the time being in force and also the provisions of other labour laws
- as are applicable to the workmen engaged in the quarries and any other relevant laws for the time being in force.

  32. In case of any tree/ plantation is removed during quarrying activity, the lease holder will plant a minimum of twice the number of such plants, which will be in addition to the plantation to be done otherwise as per quarry plan Before removal of any tree permission of competent authority shall be obtained.
- 33. **Over burden** and other waste if any, should be dumped at identified sites using proper techniques and precautions. Dumps the stabilised suitably by formation of retaining wall/ check dams at outer periphery of dumping sites followed by plantation. Inactive dumps should be covered under the plantation wherever required as proposed under quarry plan. Garland drain should be constructed around the waste dump site inside area to prevent run off

from the waste dump to arrest siltation.

- 34. Regular sprinkling of water be carried out to ensure that the suspended particulate matter level does not exceed the ambient air quality standards, within the entire quarry leased area and the pathways leading to quarry area.
- 35. Sampling of ambient air quality in the core zone for suspended particulate matter, respirable particulate matter sulphur dioxide, oxides of nitrogen should be carried out once in every six months in the consultation with the pollution control committee, Sri Vijaya Puram.
- 36. The overall noise level in and around the quarry area will be kept well within prescribed limits of noise emissions as per Environment Protection Act, 1986 and rules framed there under.
- 37. That the lease holder shall carry out quarrying in accordance with all other provisions applicable for undertaking quarrying including the provisions of Forest(Conservation) Act, 1980 and Environment(Protection) Act, 1986 and the rules made there under.
- 38. The lease holder shall abide all the conditions laid down in the Environment Clearance granted by the competent Authority vide EC identification No. EC24C0108AN5721433N and EC24C01108AN5248734N and the lease holder shall comply/abide with any additional terms/conditions if any stipulated at any time and all environmental concerns and the safety of the workers are to be addressed.
- 39. Apart from above, the provisions of Water (Prevention and Control of Pollution) Act, 1974, Air (Prevention and Control of Pollution) Act, 1981, Environment (Protection) Act, 1986 and the rules and regulation under Public liability insurance act, 1991 shall also be enforced.
- 40. That the lease holder shall without delay send a report of any accident, causing loss of life or serious bodily injuries or endangering life or property which may at any time occur at or in the said land during the course of operations undertaken under the lease, to the Tehsildar concerned and the Deputy Commissioner.
- 41. That the lease holder shall submit returns and maintain requisite register and memorandums as prescribed under the A & N Islands Minor Minerals Rules, 2012.
- 42. That on expiry or premature termination of the lease, the quarried materials, lying on the land from which they are extracted, shall become the absolute property of the administration.
- 43. Force Majeure means such of the following factors which substantially affect the performance of the agreement, such as: natural phenomena, including but not limited to floods, draughts, earthquakes, Cyclones and Epidemics; acts of any Government, domestic or foreign, including but not limited to war, declared or undeclared, quarantines, embargoes. Either party shall within fifteen (15) days from the occurrence of such a cause notify the other in writing of such causes.
- 44. The Lessee or the Deputy Commissioner (South Andaman) shall not be liable for delays in performing their obligations resulting from any Force Majeure cause as referred to and/or defined above.
- 45. However, if such an event lasts for a period of 90 days or more than either party shall have an option to terminate this Agreement forthwith without any liability after intimating the other party of the same and such event shall be governed by Rule 46 of ANIMMR, 2012.


