concepts of good touch and bad touch, and explained the working mechanisms and implementation of the POSH Act to ensure a safe and dignified workplace for women.

Shri Rashid Alam, Member Secretary of A&N SLSA, also addressed the gathering and explained the objectives and key provisions of POCSO Act, which provides for stringent punishment for sexual offences against children and mandates child-friendly procedures during investigation and trial. He further highlighted the POSH Act, emphasizing the legal obligations of every workplace to constitute Internal Complaints Committees, provide a safe environment free from harassment, and take prompt action on complaints. He stressed that awareness and timely reporting are conducted castration on 12 piglets across two essential to protect the rights of victims and uphold the rule of law.

Ms. Tasneem Abid, Learned Special Public Prosecutor, spoke in detail about the sensitive handling of POCSO victims, emphasizing the importance of creating a supportive environment, maintaining empathy, and ensuring that girl children are kept in safe custody and protective care. She highlighted the responsibilities of all stakeholders-including police officers, medical professionals, and welfare authorities-to protect the rights and dignity of minor victims at every stage of the process.

Shri Niyaz Alam, Learned Additional District & Sessions Judge and Special Judge for POCSO cases, explained the special procedures prescribed under the POCSO Act to maintain the privacy and confidentiality of victims, including in-camera proceedings, restrictions on media reporting, and strict prohibitions on disclosing the identity of the child victim. He underscored the importance of a victim-centric approach to investigation and trial and the need to create a safe space to reduce trauma and ensure access to justice.

Shri Samrat Roy, Secretary, DLSA, also highlighted the various initiatives of the Legal Services Authorities, including free legal aid and teamwork, and motivate them to services, victim compensation schemes, and the NALSA SAATHI campaign, which focuses on Aadhaar registration, legal identity, and the empowerment of destitute children through access to welfare said. entitlements and protection under child welfare laws.

The programme concluded with a vote of thanks proposed by Shri R. Together, these AI-enabled platforms are not only preserving and validating India's traditional knowledge systems of medicine but are also advancing their global integration within evidence-based, digital healthcare frameworks."

This WHO publication not only validates India's growing influence in the global traditional medicine landscape but also acknowledges several key Indian innovations in the AI and Ayush space.

The document showcases a range of AI-driven applications in Ayurveda, Siddha, Unani, Sowa Rigpa, and Homoeopathy, including diagnosis support systems that integrate traditional methods like pulse reading, tongue examination, and Prakriti assessment with machine learning algorithms and deep neural networks. These efforts are enhancing diagnostic accuracy and enabling personalised preventive care.

One of the standout features in the WHO brief is the mention of Ayurgenomics, a scientific breakthrough that combines genomics with Ayurvedic principles. This initiative aims to identify predictive disease markers and personalise health recommendations using AI-based analysis of Ayurvedic constitution types. The document also highlights efforts to decode the genomic and molecular basis of herbal formulations for repurposing in modern disease conditions-a major leap in integrating traditional wisdom with contemporary science.

India's initiatives to digitise traditional knowledge, such as the Traditional Knowledge Digital Library (TKDL), are praised as global models for the preservation and responsible use of indigenous medical heritage. Furthermore, AI-powered tools are being used for cataloguing and semantic analysis of ancient texts, enabling easier access to time-tested therapeutic knowledge.

Another critical aspect recognised by the WHO is the use of AI for drug action pathway identification, comparative studies across systems like Ayurveda, TCM, and Unani, and the development of artificial chemical sensors to assess traditional parameters such as Rasa, Guna, and Virya. These technological interventions are helping validate and modernise traditional formulations.

The document also applauds India's broader efforts in incorporating digital platforms for online consultations, promoting digital literacy among Ayush practitioners, and building interoperable systems to integrate traditional medicine with mainstream healthcare.


