## Clinical Establishment Act: ensuring consistency across clinical establishments People urged to share information on quack doctors practicing medicine and sale of fake drugs

Port Blair, June 6

The Clinical Establishment Act (Registration & Regulation) Act, 2010 has been enacted by the Government of India to provide for registration and regulation of all clinical establishment including hospitals, nursing homes, single Doctor Clinics, Diagnostic Centres and others in Government as well as private sector. This Act prescribes minimum standards of facilities and services, including details of personnel, which may be provided by them so that mandate of Article-47 of the Constitution for improvement in public health may be

achieved.

The Clinical Establishment Act aims to instil uniformity and transparency in provision of health care services for patients. Major objectives of this legislation is to create a standard framework to ensure consistency across clinical establishments.

Whereas, there still exist threat of quack doctors practicing medicine and sale of fake drugs within State/Union Territories. Quack doctor within the healthcare system poses a significant threat to public health, as these individual lack necessary qualification and

expertise to provide safe and effective medical care. Furthermore, sale of counterfeit drug not only jeopardizes health of patients but also undermines integrity of modern healthcare system.

This Act empowers the District Registering Authority to take action including imposing penalties/ shutdown in respect of violation of provisions of the Andaman And Nicobar Gazette Notification vide No. 44 dated 06th March, 2013 under Rule No.8 Penalties & Appeals "In keeping with the

provisions of Section 41(1), (2), (3) Section 42 (1), (2), (3) the Act, whoever carries on a Clinical Establishment without registration or whoever wilfully disobeys any direction, or obstructs any person or authority or withholds any such information or provides false information shall be liable for a monetary penalty".

Whoever carried on a Clinical Establishment without registration, shall, on first contravention be (Contd. on last page)

**Rough Sea Alert:** Highwave watch for the coast of Car Nicobar, Andaman and Nicobar. Highwaves in the range of 1.9 - 3.0 meters have been forecasted till 23:30 hours on 07-06-2024.

**Swell wave Alert for the Andaman and Nicobar Coast:** Swell waves in the range of 14.0 - 20.0 sec period with 1.2 - 2.8 m height have been forecasted till 23:30 hours on 07-

06-2024. There is a possibility of surging of waves, boats have been advised to ply with utmost vigilance, recreation with due care.

**Swell Surge Warning for the Coast of Indira Point, A&N:** Swell waves in the range of 19.0 -20.0 sec period with 2.5 - 2.8 m height have been forecasted till 23:30 hours on 07-06-2024. Surging of waves near shore is possible, hence, small vessels have been advised not to ply, and no activities should be organized at beach/

near shore waters as near shore erosion is possible. No exit/entry of small boats at coastline.

liable to a monetary penalty upto fifty thousand rupees, for second contravention to a monetary penalty which may extend to two lakh rupees and for any subsequent contravention to penalty which may extend to five lakh rupees.

Whoever knowingly serves in a Clinical Establishment which is not duly registered under this Act, shall be liable to a monetary penalty which may extend to twenty five thousand rupees".

PS Mayabunder cracks night burglary case

Mayabunder, June 6  
A complaint of night burglary at a shop in Mayabunder Bazaar was reported by a shop owner at PS Mayabunder on June 6, 2024. Upon this, a special team, led by Inspector P.K. Abdul Arif, SHO, PS Mayabunder, including PCs Dilleswar Rao, Sailen Pandey, M. Nasir and Rajesh (IRBn) was constituted to track down the culprit. The team conducted a comprehensive search, alerted informers and gathered intelligence. With the thorough efforts of the team, Saw Hteemothel, S/o Shri Saw Ahdeeh, 19 yrs, R/o Webi, Mayabunder was identified the prime suspect and a CCL (Child in conflict with Law) also involved in the theft. Acting swiftly, they devised a plan and successfully apprehended the accused and the CCL.

On a thorough interrogation, he admitted his involvement in theft and the stolen cash was successfully recovered from the accused within 3 hours of registration of case.

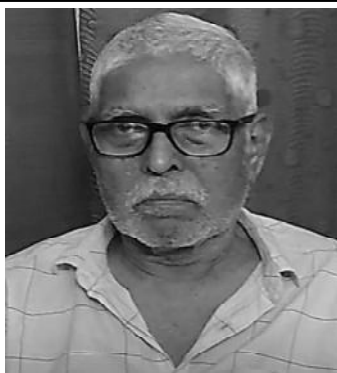
