## Rediscovering Andaman: New Resorts, Heritage Circuits, Astrotourism & More in The Works

Your next trip to the Andaman Islands could become more immersive and experiential, thanks in parts to a slew of new upgrades and nitiatives being announced for the archipelago

The Andaman and Nicobar Islands, India's crown jewels in the Bay of Bengal, are preparing for a luxe upgrade. From luxury resorts and a yacht marina to heritage circuits and astro-tourism, the island chain will soon start on a future-facing roadmap to become a world-class travel destination.

Speaking to PTI, Chief Secretary, Dr. Chandra Bhushan Kumar confirmed that the administration, under the guidance of the Union

Ministry of Home Affairs, has approved major projects that aim to improve and upgrade the travel offerings of the islands, while preserving its ecosystem.

"The Andaman and Nicobar archipelago, comprising 836 islands, is a rare blend of natural beauty, historical depth, and adventure tourism. We aim to elevate it to international tourism standards," Kumar said. Luxury On The Horizon: Five-Star Resorts & Private Yachts

The biggest highlight? The greenlight for the construction of four five-star resorts on select islands, which will make Andaman a premium luxury destination. Details of the resort locations are expected soon, but they are part of a broader push to attract high-value, low-impact tourism. Andaman's Swaraj Dweep already has a few luxury

Complementing this is the proposal for a dedicated yacht marina, with an Expression of Interest (EoI) already issued. This marina is designed to attract private yachts and cruise vessels, placing the islands on the global luxury cruising map.

Plus, adding to a burgeoning water sports industry, Andaman is set to expand its eco-tourism and marine adventure offerings, including scuba diving, game fishing, and snorkelling. These activities will now operate under enhanced safety protocols with

professionally trained operators. Interestingly, the focus is no longer just on the usual suspects. Swaraj Dweep and Shaheed Dweep. Islands like Baratang, known for mud volcanoes and limestone caves, are now in the spotlight. Astro-Tourism Comes To The Islands

Andaman is also tapping into its unpolluted, dark skies to introduce astro-tourism, a trend rapidly gaining popularity across global travel circuits. While some hotels already have stargazing experiences in the repertoire, the offerings will be extended to other resorts.

#### Heritage Circuit To Bring India's Freedom Struggle To Life

The administration is also reviving the islands' deep connection with India's freedom movement. The Cellular Jail, already on UNESCO's tentative list, is being pitched for World Heritage Site status. A new tourism circuit connecting Cellular Jail, Netaji Subhas Chandra Bose Island, and Viper Island is in development, offering light and sound shows, immersive tours, and storytelling-led heritage experiences. #### **CIRCULAR**

This is with reference to the review meeting held today on the current status of the TB elimination programme in the South Andaman District. The Medical Superintendent / Chief Medical Officer / Medical Officer In-Charge of the Medical College, District Hospital, Community Health Centres, Primary Health Centres, and Urban Health Centres are hereby instructed to comply with the following directives to ensure coordinated and intensified efforts toward achieving the goal of TB elimination:

▶ Mobilize Ground-Level Workers such as ASHAs, ANMs, CHOs, and other field-level staff to identify vulnerable groups suspected of the Cuisines of India form. The rent for Live TB. A health centre-wise list must be prepared and shared promptly with the District TB Unit and District Control Room.

> The Medical Officer In-Charge shall prepare a detailed plan within 15 days for mobilizing individuals for TB screening. field-level staff for active identification of TB suspects especially among clarity on Financial Literacy. high-risk and vulnerable groups. Each health facility shall prepare and submit a revised list of suspected cases with mandatory and immediate entry of the data into the Nikshay Portal, the national TB surveillance system.

Further, all Health Centres have been instructed to chalk out a detailed micro-plan within the next 15 days, ensuring door-to-door mobilisation and TB screening of the target population. The involvement of all units of the Health Department along with key line Departments such as ICDS, Rural Development, Education and Labour is being ensured to widen the net of detection and referral in accordance with national guidelines.

To facilitate coordination and ensure close monitoring, a District TB Control Room is being established with immediate effect and will be responsible for collecting daily progress reports from all health facilities, identifying implementation bottlenecks, and guiding corrective measures in real-time.

Recognizing the importance of community-based support for TB patients NGOs and civil society partners will be encouraged to adopt TB patients, support treatment adherence and assist in nutritional and psychological support, thereby enhancing treatment outcomes.

The District Administration, South Andaman and Directorate of Health Services have jointly emphasized that all TB-related interventions must be executed in a strict mission-mode approach with fixed timelines and measurable outcomes.

Shri Arjun Sharma, IAS, Deputy Commissioner, South Andaman has strongly urged the general public to support this critical public health mission. Anyone experiencing symptoms such as persistent cough for more than two weeks, fever, night sweats, weight loss or general weakness has been advised to visit the nearest Government health facility for free TB screening and treatment. Community participation is key to eliminating TB and the District Administration, South Andaman has appealed to all citizens to come forward, cooperate with health workers, and contribute to a TB-free future, a press release received from DC (SA)


