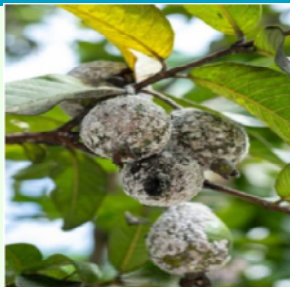

In view of the emerging pest damage, especially Rugose Spiraling Whitefly and Mealy Bug infestation in Coconut, Arecanut, and other fruit crops, the Secretary (Agriculture), Ms. Pallavi Sarkar, IAS, has taken initiative to equip the Officers and Officials of the Agriculture Department with better knowledge on the pest identification and management

practices. This initiative aims to ensure effective implementation of pest control strategies at the farmers' field level. In this connection, an orientation and lecture on IPM techniques for Rugose Spiraling Whitefly and Mealy Bug infestation were conducted in association with experts from Kerala Agricultural University & ICAR-CIARI through virtual mode yesterday for Agriculture Officers and extension

functionaries including ATMA staff of the Agriculture Department. Dr. Manichellapan, Dean from College of Agriculture, Kerala Agricultural University and Shri Mohit, Subject Matter Specialist from Krishi Vigyan Kendra, Sippighat delivered the session through power point presentation.

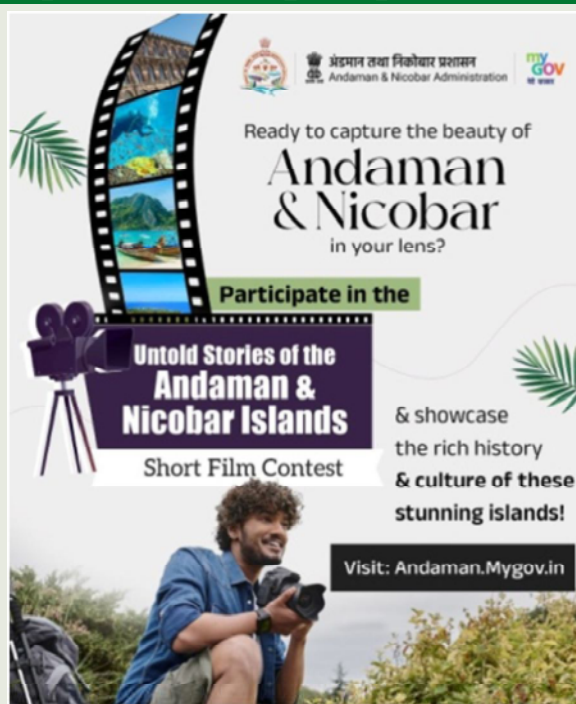
Dr. Manichellapan delivered an insightful presentation on the identification and

## District Administration, SA imposes fines against illegal extraction, dumping and unauthorized transportation of earth

Sri Vijaya Puram, Mar. 1

The District Administration, South Andaman has taken strict action against violators who were indulged in illegal extraction and unauthorized Transportation of earth in contravention of Land Revenue Regulations.

During a recent field inspection, the Revenue Officials of Ferrargunj Tehsil detected 2 Nos. of trucks transporting earth at Wandoor village without valid transit passes. As a result, a fine of Rs 44,000/- was imposed. Additionally, in Guptapara village, Revenue Officials found illegal extraction and dumping of earth, the violator was penalized with a fine of Rs 30,000/- for the offense.

In another inspection at Sri Vijaya Puram Tehsil, the Revenue Authorities found illegal extraction and dumping of earth during night hours using one JCB and two Hitachi machine. The machinery was seized and a fine of Rs 12,30,000/- was imposed on the violators.

The Deputy Commissioner, South Andaman has warned unscrupulous elements involved in illegal extraction and violation of Andaman and Nicobar Islands Land Revenue and Land Reforms Regulation 1966 to desist from indulging in such acts in future failing which stern action would be taken against them, a press release received from DC (SA) said.

## Mock Drill conducted at DSS & PMB to enhance disaster preparedness

In accordance with the directive of the Chief Secretary, A&N Administration, mandating quarterly mock drills across all Departments, the Directorate of Disaster Management conducted Mock Drills in the Directorate of Shipping Services (DSS) and the Port Management Board (PMB), A&N Administration yesterday.

The objective was to assess their preparedness in responding to earthquakes and tsunamis.



The drill commenced at 1100 hrs, with active participation from all staff and officials of both Departments. Real-time simulations of earthquake and tsunami scenarios were executed to test

response mechanisms. The teams effectively communicated with the State Emergency Operation Centre (SEOC), District Emergency Operation Centre (DEOC - S/A), Fire, Police, Electricity, NDRE, Transport, and Health Departments to seek necessary support.

During the exercise, safe evacuation procedures were followed, search and rescue operations were carried out, and first aid was provided to injured personnel. Resource department teams coordinated with DSS and PMB to

ensure the successful execution of the drill.

The drill concluded at 1200 hrs, followed by a debriefing session. Incident Commanders and observers appreciated the participation and efforts of the staff and officials. They also emphasized the importance of conducting such drills regularly to identify and address any gaps in disaster preparedness, a press release from Directorate of Disaster Management said.

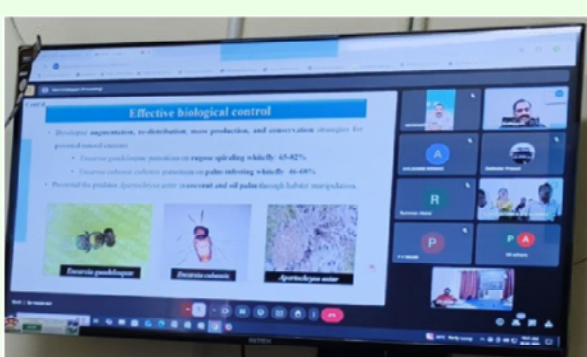

Ramakrishna, Principal Scientist & Head, KVK, focused on practical strategies that can be implemented in the field.

The lecture concluded with an interactive Q&A session, where extension functionaries from various zones raised concerns and sought expert guidance on pest management. The event proved to be an informative and engaging platform for knowledge-sharing, equipping agriculture officials with enhanced skills to combat pest infestations effectively, a press release from Agriculture Deptt. said.

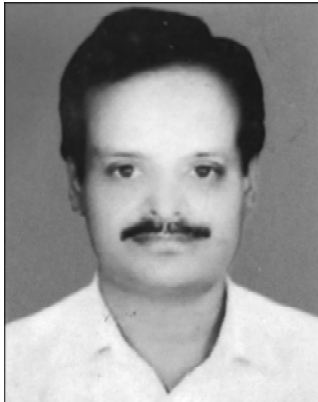
