



General Elections-2024 : Model Conduct of Conduct ECI issues instructions to regulate road shows to avoid any inconvenience to general public/commuters

Port Blair, Mar. 21

With the announcement of General Elections-2024 by the Election Commission of India on 16/03/2024, the Model Code of Conduct has come into force with immediate

In this regard, the Election Commission of India has issued the following instructions to regulate road shows to avoid any inconvenience to the general public/ commuters during road shows which is detailed as under:-

- Prior permission for road shows carried with hand would be 6x4 feet. shall be taken from the Competent > Authority.
- In order to avoid inconvenience to this subject. general public, as far as possible, road 🕨 laws, should be permitted only on not take part in road shows. hospitals, trauma centers, blood banks in a road show. and heavily crowded markets.
- intimated in advance.
- The road show shall not cover more than half the road width to ensure safety of the general public.
- The convoy of vehicles being used every 10 vehicles and a gap of 100 meters would be maintained.
- Safety of public and persons in the road show shall be ensured. Bursting of fire crackers and carrying of fire arms shall not be permitted at all.

AND WHEREAS the infrastructure support to the election machinery is to be drawn from Central Government, UT Administration, Public Undertakings of Central and UT Administration, Local Bodies, Municipalities, Marketing Board by whatever name known, Cooperative Societies, Autonomous District Councils or any other body in which public fund and Private Owners and they may be required to provide the vehicles, vessels, boat, premises etc. possessed by them to the Returning Officer, District Election Officers or the officers subordinate to them. In view of this, provision under Section 160 of the Representation of People Act, 1951 to requisite vehicles, vessels, boat, premises etc. of the Central Govt., UT Administration, Public Undertaking of Central and UT Administration, Local Bodies, Municipalities, Marketing Board by whatever name known, Cooperative Societies, Autonomous District Councils or any other body in which public fund and Private Owners will have to be invoked for the smooth conduct of the elections;

NOW THEREFORE, in exercise of the powers conferred under Section 160 of, Representation of Peoples Act, 1951, I, Admiral D K Joshi, PVSM, AVSM, YSM, NM, VSM (Retd.) Lieutenant Governor (Administrator) Andaman and Nicobar Islands do hereby delegate the powers conferred on me under Section 160 of Representation of Peoples Act, 1951 read with Rule 98 of Conduct of Election Rules, 1961 to the officers shown in the schedule below.

The Officers mentioned at Column (2) of the schedule below shall exercise the powers under the said law mentioned above for the conduct of General Election to Lok Sabha, 2024 in the jurisdiction mentioned in Column (3) of the said schedule with immediate effect subject to conditions as specified in the Act/Rules.


