Primary Health Centres (PHCs), Community Health Centres (CHCs) and District Hospitals of A&N Islands.

The session was conducted by the resource person, Dr. Shiv Shankar Singh, M.D (Medicine), who imparted a detailed training on the clinical management and response to snake bite. The training aims to enhance the knowledge and preparedness of healthcare professionals in effectively managing snake bite cases, proper referral mechanisms administration of anti-snake venom (ASV) and treatment associated with snake envenomation which is considered a critical aspect of emergency healthcare services.

Around 54 participants were benefitted from this virtual training programme. The virtual training was organized under the guidance of Dr. Subrata Saha, State Nodal Officer (PCSBE). Dr. Rajiv Ghosh, District Public Health Officer reiterated the Directorate's commitment to strengthening emergency healthcare services at all levels. Earlier, Smt. Banani Mridha, Bio Medical Engineer welcomed the gathering.


