India and Pakistan Agree on Immediate Ceasefire

New Delhi, May 10

India and Pakistan today announced a ceasefire, agreeing to stop firing and military action with immediate effect. Foreign Secretary, Shri Vikram Misri made this announcement in New Delhi. He said, Pakistan's Director General of Military Operations initiated the call for a ceasefire this afternoon, after which discussions took place and an understanding was reached.

He said that during the talks, it was agreed that both sides would stop all firing and military action on land, in the air, and at sea.



Instructions have been given on both sides to give effect to this understanding. Shri Misri added that the Directors General of Military Operations will talk again on Monday. (Source: newsonair.gov.in)

India Dismantles Pakistan's Military Capabilities in Operation Sindoor

New Delhi, May 10

Pakistan has suffered heavy losses after its provocative action against India, as New Delhi dismantled Islamabad's offensive and defensive capabilities through its Operation Sindoor. Briefing media in New Delhi, Indian Army's Colonel Sofiya Qureshi said, India's operations have been aimed exclusively at terrorist camps and facilities being used for anti-India activities. She said that Pakistan made several attempts to propagate misinformation, and Pakistan's claim of



destroying India's S400 and Brahmos missile base with its JF-17 was completely fabricated. In a strong rebuttal, Colonel Qureshi dismissed Islamabad's claim of damaging several key military assets of India.

Dismissing Pakistan's allegations that Indian Armed Forces targeted religious sites, Colonel Qureshi

asserted that India is a secular nation and its Armed Forces are a very beautiful reflection of the constitutional values.

During the briefing, Air Force Wing Commander Vyomika Singh dismissed disinformation spread by Pakistan that India's airfields in Sirsa, Jammu, Pathankot,

Bhatinda, Nalia and Bhuj were damaged. Meanwhile, Navy's Commodore Raghu Nair said that since the tragic events at Pahalgam, India's responses have been measured and responsible. He said there's a significant amount of misinformation being spread from the other side. Commodore Nair asserted that India will be adhering to the understanding that has been reached today, but any future escalation will invite a decisive response. (Source: newsonair.gov.in)

Saturation drive underway for release of 20th Installment under PM-KISAN Scheme

Left out farmers urged to attend campaign in their respective Gram Panchayats with documents

Sri Vijaya Puram, May 10

The Government with a view to augment the income of the farmers, launched the Central Sector Scheme - "Pradhan Mantri Kisan Samman Nidhi" (PM-KISAN) during the financial year of 2018-19 which is 100% funded by Govt. of India. Under the Scheme, eligible farmer families receive financial benefits of Rs. 6000/- per year payable in 3 equal installments

of Rs. 2000/- each, every four months. Till now, 19 Installments have been released by the GoI. The 19th Installment was released by the Hon'ble Prime Minister, Shri Narendra Modi on 24th February, 2025 directly to the bank accounts of the PM K I S A N beneficiaries. The 20th Installment is expected to be released tentatively in the month of June, 2025 for the

period April to July. To ensure that no eligible farmer is left out under the PM-KISAN, the Ministry has launched a month-long nationwide PM-KISAN Saturation Campaign from 1st May, 2025 to 31st May, 2025. The left out farmers may attend the campaign in their respective Gram panchayats with their documents viz. Latest Land Records, Bank Account Pass Book, Aadhaar Card

and Ration Card. Other PM-KISAN beneficiaries who have so far not done their land seeding, e-KYC and Bank Account seeding with Aadhaar have been requested to complete the process before 31st May, 2025. If the mandatory requirements are not done, then the benefits of 20th Installment will not be released to them in time. For any query/doubt related to land

seeding, Bank Account seeding & e-KYC, the beneficiaries can also contact the concerned Zonal Agriculture Office/Field Extension functionaries of Agriculture Department. Self-registration and e-KYC may be done only through the official website of PM-KISAN portal & PM-KISAN app and it is advised not to download or use any other applications, a press release from Agriculture Deptt. said.

SRS 2021: India Reports Decline in Maternal, Infant, and Child Mortality; Sex Ratio at Birth Improves

New Delhi, May 10 India has witnessed a steady downward trend in maternal and child mortality towards the achievement of Sustainable Development Goal 2030 targets. As per the Sample Registration System (SRS) Report 2021, released by the Registrar General of India (RGI), Maternal Mortality Ratio dropped significantly

from 130 to 93 per lakh live births. The report mentioned that Infant Mortality Rate has also declined from 39 per 1000 live births in 2014 to 27 per 1000 live births in 2021, while, Neonatal Mortality Rate decreased from 26 per thousand live births in 2014 to 19 per thousand live births in 2021.

The report further stated, Under-Five

Mortality Rate has declined from 45 per thousand live births in 2014 to 31 per thousand live births in 2021. The Sex Ratio at Birth improves from 899 in 2014 to 913 in 2021. Total Fertility Rate is consistent at 2.0 in 2021, which is a significant improvement from 2.3 in 2014. (Source: newsonair.gov.in)
