

Applications in the prescribed form are invited from eligible candidates those who are Indian citizens for enrollment as Home Guard Volunteers for Law & Order and other multifarious duties in Andaman & Nicobar Home Guard Organization to fill up the existing vacancies for all three districts in this UT of Andaman & Nicobar Islands purely on voluntary basis for a period of three years.
