Skin flap restored in a case of comminuted fracture after road accident on a young patient

Port Blair, May 14

A 20 year old ITI student was brought to GBPH with fracture of left thigh bone and multiple breaks of lower leg bones on the same side. He had met

with a road traffic accident at Lamba Line on 16th March, 2024.As the patient was brought to the hospital, he was bleeding profusely since all the long bones of his left leg

were badly fractured. After the patient's blood loss was restored, his thigh bone was operated upon by the Orthopedics team on 17th March. The definitive surgery for

the fracture of bones of lower leg (below knee) was purposively delayed since a large part of skin was lost, exposing the bone. However, regular

40 schools secured 100% results in Class X

Significant increase in pass percentage in both Class X & XII compared to last year

Port Blair, May 14

The result of All India Secondary School Examination, 2024 (Class X) and All India Senior Secondary School Certificate Examination, 2024 (Class XII) has been declared on 13th May, 2024.

As per the press release received from Directorate of Education, a total of 4858 students appeared in class XII from the Government

and private schools of A & N Islands, out of which, 4590 students passed and 219 students have been placed in compartment. The overall pass percentage of A & N Islands for class XII during this year is 94.48% whereas, the result of last year

2023 was 83.44% which is a significant increase of 11.04%.

A total of 5475 students appeared in class X from the Government and private schools of A & N Islands, out of which, 4900 students passed and 532

students have been placed in compartment. The overall pass percentage of A & N Islands for class X during this year is 89.50% whereas, the result of last year 2023 was 84.34% which is a significant increase of 5.16%.

District Revenue Officials restore public land on sixth day of Encroachment Eviction Drive at N&M Andaman

South Andaman Police's successful crack-down on immoral activities

The South Andaman District Police has once again showed its mettle in curbing down the menace of illegal activities in the district and succeeded in apprehension of 03 persons for involvement in prostitution.

On May 13, 2024, Shri Vinay Mathur, SDPO Bambooflat, reported to PS Pahargaon followed by direction received from senior officers based on reliable information. The information was received that Smti Soma Mondal was allegedly running a brothel in a rented house at Dollygunj. Acting on this information, a raiding team comprising of Ms Anushtha Kalia, IPS (P), SI Sudhir Kumar, HC MS Anil Kumar,

PCs T. Venkateshwar Rao, Lendha Horo, Vinod, R. Devika, V A Prabhakaran, and Abhay Kumar Yadav of PS Pahargaon along with independent witnesses was formed. The raiding team along with independent witnesses conducted a raid on the rented residence at Dollygunj. During the raid, Soma Mondal, Rinku Jana and M. Farida Bibi were found indulging in immoral activities. During raid, sufficient evidence was collected indicating the involvement of the three women in acts of prostitution. Further, all three women confessed to their involvement in the acts of prostitution. All three were arrested on the spot under the

Immoral Traffic (Prevention) Act, 1956 after observing all codal formalities. This successful operation is a testament to the dedication of law enforcement in combating immoral trafficking. The raids took place under the supervision of Smti Niharika Bhatt, IPS, Superintendent of Police South Andaman District. South Andaman District Police will continue stringent actions against the wrong-doers in future too.

dressings were done to prevent infection of the injury site.

Two days later, when the thigh bone fracture was stabilized, a team of doctors from ANIIMS comprising of Dr. P.N Suparna, Plastic Surgeon along with Orthopediacians, Dr. Kartik Pande and Dr. Humam Ahmad fixed the fracture of lower leg bone by applying an external fixator to hold the comminuted (more than two pieces) bones in alignment.

The plastic surgeon removed a full thickness skin graft from the right leg (Calf region) of the patient to cover for the loss of skin in the left leg. The two limbs were kept close to each other and the flap was sutured to the left leg recipient area and the donor site was covered with a split skin graft from the right thigh. Once the flap taken up at the open skin loss area heals, final fixation with a nail will be done by the team.

For the first time, the Surgery Department of GBPH has added the facility of Plastic Surgery by appointing Dr. PN Suparna, who has completed her MCH in Plastic Surgery from Nair Hospital, Mumbai. This brings a ray of hope to the Islanders as addition of this super specialist service in GBPH will curtail the need of referring the patients to mainland and the plastic surgery procedure can now be done in Port Blair itself with precision and accuracy by the expert specialist. With the addition of this facility, complex open fractures with significant skin loss that earlier required referrals to the mainland which will now be done at Port Blair itself. This is addition of a new super-specialist service to GBPH and there are more to come, a press release from ANIIMS said.


