The District Industries Centre (DIC), Department of Industries, Andaman & Nicobar Islands, is pleased to share a major policy announcement by the Government of India aimed at empowering Micro, Small, and Medium Enterprises (MSMEs) across the country, including the entrepreneurial community in A&N Islands. As per the Union Budget 2025-26 presented by Hon'ble Finance Minister, Smt. Nirmala Sitharaman, the definition of MSMEs has been significantly revised to facilitate greater inclusion, Ease of Doing Business and access to support schemes. 
