Revised MSME Definition - A Transformational Step for MSMEs

All unregistered entrepreneurs of Isles encouraged to come forward and register their units on Udyam portal

Sri Vijaya Puram, May 22

The District Industries Centre (DIC), Department of Industries, Andaman & Nicobar Islands, is pleased to share a major policy announcement by the Government of India aimed at empowering Micro, Small, and Medium Enterprises (MSMEs) across the country, including the entrepreneurial community in A&N Islands. As per the Union Budget 2025-26 presented by Hon'ble Finance Minister, Smt. Nirmala Sitharaman, the definition of MSMEs has been significantly revised to facilitate greater inclusion, Ease of Doing Business and access to support schemes. The new classification is as follows:

This expanded scope will allow a wider range of enterprises in the Andaman & Nicobar Islands to register and benefit from MSME schemes and initiatives.

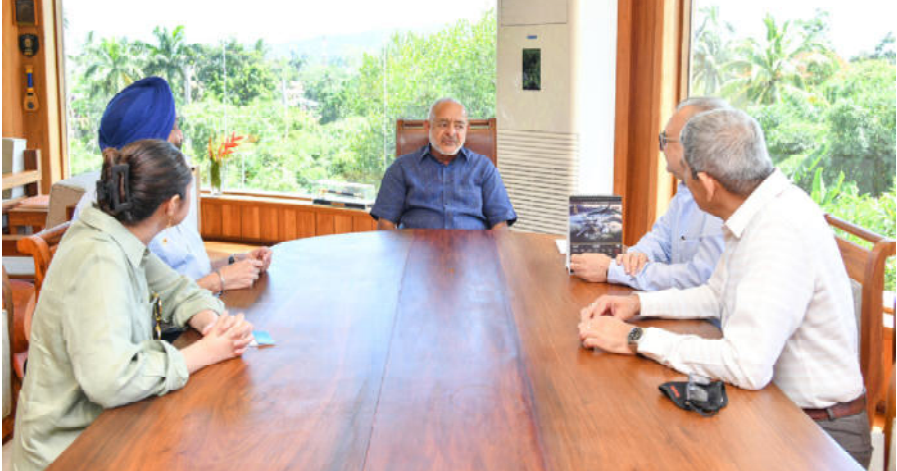
The revised definition opens up new avenues for local entrepreneurs and businesses to grow with enhanced access to financial assistance, Government subsidies, and procurement preferences. The Credit Guarantee Scheme has been upgraded, now offering credit up to Rs.10 crore and further reduction in Annual

Guarantee Fee for guarantees above Rs.1 Crore to Rs. 5 Crores. In addition, the Government has announced the introduction of 10 lakh customized credit cards for micro enterprises registered on the Udyam portal, with each card offering a Rs. 5 lakh limit in the first year. This move will be a great enabler for small-scale entrepreneurs in remote areas like the islands, giving them reliable access to working capital.

The DIC, Andaman & Nicobar Islands encourages all unregistered entrepreneurs to come forward and register their units on the Udyam portal if not

already registered till date to take full advantage of these benefits. Existing entrepreneurs registered in Udyam Portal may also update and reprint their Udyam certificates to classify their units as per the new definition. This redefinition of MSMEs is a crucial step towards promoting innovation, employment and inclusive development.

District Administration, SA reclaims Govt. land from encroachers in North Bay village

competitions is the same. 1st prize is set at Rs.3000, 2nd prize at Rs.2000 and 3rd prize at Rs.1500, followed by two consolation prizes of Rs.500 each. The Directorate of Information, Publicity & Tourism, A & N Administration has informed that a 'Standard Operating Procedure (SOP) for Fly Board/Water Jet Pack adventure watersports activity in A&N Islands' has been prepared in coordination and consultation with Rashtriya Life Saving Society (India).

Fly Board/Water Jet Pack is an adventure water sports activity also known as water flight or water jet packing. The water sports combine the thrill of flight with the power propulsion that is connected to a 'Jet Ski' by a long hose. The Jet Ski pumps water through the hose and forces it through nozzles beneath the board, lifting the rider into

the air. The draft SOP outlines safety procedures, supervision, requirements for water jet pack/fly-board, equipment, man power, briefing procedure etc.

Significant quantity of illicit liquor
destroyed by South Andaman Forest Division

Sri Vijaya Puram, May 22 During routine beat patrolling yesterday in Bimblitan Reserved Forest Area under South Andaman Forest Division, the forest team members comprising of Beat Officer, Shri Shyam Sunder Rao (Forester), Departmental Mazdoors, Shri P Papa Rao, Shri Randhir Soreng & others detected an illicit country liquor preparation site inside the dense forest area.

On further investigation, the team found 350 liters of Lahan (Fermented base for making country liquor) along with used utensils i.e. 02 nos. Plastic Jerrican (20 Liters), 2 nos. Iron cask (200 L capacity), 2 nos. Empty Tin containers (15L capacity) and 01 no. illicit liquor iron spoon attached with hole in bamboo in a



small cleared patch inside the forest area.

The team tried to search for the offenders in the forest area but nobody was found. Following the seizure by the Beat Officer, Bimblitan, all confiscated 350 liters of Lahan was destroyed on the spot and the remaining items were seized U/s Sec. 52 (1) of Indian Forest Act, 1927 and handed over the same to Camp Officer, Head Quarter, Garacharma Range under South Andaman Forest Division for safe custody.

The entire operation was conducted under the

supervision of Forest Range Officer, Garacharma Range with active guidance by the Assistant Conservator of Forests (South Andaman Forest Division).

General public have been requested to play an active role in combating the illegal offences inside Reserved Forest areas/ Protected areas and reporting any instances of Forest or Wildlife related crimes to the South Andaman Forest Division at helpline number 03192-255228. Informants' identities will be kept confidential in all manners, a press release from DFO (SA) said.
