





Blind hit-and-run case solved by Police Station Aberdeen

Sri Vijaya Puram, May 27  
Towards the commitment of zero tolerance against any crime, the team of Police Station Aberdeen had successfully solved a blind hit-and-run case within 18 hours of the incident. The case occurred on 22<sup>nd</sup> May, 2025 at approximately 1830 hours at Corbyn's Cove road.

The complainant came to PS Aberdeen and reported that he was hit by an unknown vehicle and the rider fled away from the scene after the collision. Upon this, a case has been registered at Police Station Aberdeen and a

team was swiftly constituted led by Sub-Inspector Abhishek Haldar assisted by Police Constable K. Jagdish Babu.

The team began extensive search of accused by analysing the CCTV footages of the surrounding areas and gathering of intelligence through local sources. Through sustained efforts, it was discovered from a source that Saktipada Ghorai, a Chef by profession, working at a local Resort near Corbyn's Cove had recently sustained injuries matching those from a vehicular accident. Acting swiftly,

the Police team located and detained him.

Upon sustained interrogation, Saktipada Ghorai confessed to his involvement in the incident and admitted that he had fled away from the scene in an attempt to evade apprehension.

The case was solved under the guidance of Inspector Vishal Ram, SHO PS Aberdeen, under the leadership of Shri Ajay Kumar Rai, SDPO, South Andaman and overall supervision of Superintendent of Police, South Andaman, a press release from SSP, SA said.

The simulation began with an artificial earthquake scenario triggering structural damage and fire in the designated area. The Fire & Emergency Services responded swiftly by deploying fire tenders and carrying out Search and Rescue (SAR) operations. The NDRF team demonstrated their expertise in rope rescue techniques and Medical First Responder (MFR) procedures to extricate and stabilize simulated victims trapped in debris and smoke-filled environments.

Observers from all participating Departments, including the Health, NDRF and APWD, were present throughout the drill and commended the efficiency, coordination, and professionalism displayed during the operation. The Observers appreciated the realistic setup of the simulation and the proactive engagement of all response teams. inaugurated by Dr. Suja Antony, Director of Health Services, Dr. H. M Siddaraju, Joint Secretary (RCH-II), Smti D. Radhika, Vice Chairperson, SVPMC, Dr. Shreelekha, ENT Specialist, Shri B. Nagendran, District Programme Manager were present on the occasion. While addressing the gathering, Dr. Suja Antony emphasized that Anaemia is a major public health problem, more than 50% of women of reproductive age group, adolescent girls are suffering from anaemia. The long term goal of 'Anaemia Mukh Bharat' is to break the intergenerational cycle of anaemia. Dr. H.M Siddaraju while addressing the gathering said that dietary habits play a crucial role in development of iron deficiency anaemia and it is relatively easy to treat through dietary changes. Smt. D. Radhika encouraged general public to take the benefit of camp. In total, 45 beneficiaries were screened, out of which, 11 severe and 17 moderate anaemic were detected. They were treated with Tab IFA and Tab Albendazole on the spot, a press release from DHS said.
