university of agriculture. He noted that this region is home to some of the world's oldest functioning dams, and that the Kalingarayan Canal was built here in the 13th century. He highlighted that temple tanks in this region became models of decentralized water conservation systems. The Hon'ble Prime Minister stated that this land pioneered scientific water engineering thousands of years ago by regulating river water for agriculture. He expressed confidence that leadership in natural farming for the country and the world will also emerge from this very region.

Emphasising that building a futuristic agricultural ecosystem for a developed India requires collective effort, the Hon'ble Prime Minister urged farmers to begin and practice "one acre, one season" of natural farming and to move forward based on the results they observe. He appealed to scientists and research institutions to make natural farming a core part of the agricultural curriculum, encouraging them to treat farmers' fields as living laboratories. 
