And whereas, these Anti-national elements may stay in Hotels, Guest houses, Bed & Breakfast (Home Stays), Lodges, etc. while doing preparation, reconnaissance, and actual execution of these

And whereas, it is necessary to take speedy measures in this behalf, to protect property and prevent danger to human life and safety, thwart/prevent terrorist activities, which may affect and disturb Public Order and Tranquility in the Andaman and Nicobar Islands.

Now, therefore, I Arjun Sharma, District Magistrate, South Andaman, in exercise of the powers conferred upon me by virtue of Section 163 of Bharatiya Nagarik Suraksha Sanhita (BNSS)-2023 do hereby make the written order for strict compliance of following Conditions by the Owners of all such establishments in the jurisdiction of South Andaman District, of Andaman & Nicobar Islands:-1. Only those Hotels, Guest Houses, Bed & Breakfast (Home Stays), Lodges, etc. which possess valid licences, shall be allowed to function.

2. All such establishments shall have sufficient number of CCTV cameras which shall cover persons entering the premises and moving outside. All the cameras installed shall be in working condition, and their coverage shall be preserved for not less than 30 days.

3. All such Hotels, Guest Houses, Bed & Breakfast (Home Stays), Lodges, etc. shall maintain a Register-having complete details of persons staying in the said premise. A copy of the valid ID proof of such persons shall be kept for record.

4. All such Hotels, Guest Houses, Bed & Breakfast (Home Stays), Lodges, etc. shall ensure that details relating to Form-C (Arrival Report of Foreigners in Hotel) are submitted to the Registering Authorities within the prescribed period. All procedures/guidelines shall be followed in respect of any Foreign National staying in the said premise.

This order shall come into force w.e.f zero hours of 25.11.24 and shall remain in force for a period of 60 days unless withdrawn earlier.

All such Hotels, Guest Houses, Bed & Breakfast (Home Stays), Lodges, etc. which contravene this order, shall be liable to be punished in accordance with the provision of Section 208 of Bharatiya Nagarik Suraksha Sanhita (BNSS)-2023.

As this order cannot be served individually upon all concerned, this order is hereby passed Ex-Parte. It shall be published for the information of the general public through the press and by affixing copies on the Notice Boards in the offices of all SsP, DySPs, Tehsildars, Patwaries and all Police Stations.

2. Amendment in Rule 70 (5):

Sub-Rule (5) of Rule 70 of the Andaman & Nicobar Islands Motor Vehicles Rules, 2006 shall be substituted as below:-

"(5) No motor cab. other than a metered taxi and metered autorickshaw, shall be painted in a colour or colours prescribed for motor cabs in this rule and no metered taxi and metered autorickshaw shall be permitted to ply if it does not conform to the provisions of this sub-rule, namely:-

a. (i) colour of the body of all metered taxi shall be painted in white colour.

(ii) In right-hand side and left-hand side, a horizontal strip line of mystic purple colour having 06 inches thickness running from front wheel arch to rear side body and at the end of the strip, there shall be three square dots of mystic purple colour of size 06 inches x 06 inches with a gap of 02 inches in between the square dots.

(iii) The word "TAXI" shall be written at the centre in the mystic purple strips of both right-hand side and left-hand side in bold capital letters having font height of 04 inches."

(iv) The roof of the metered taxi shall be fitted with Roof top Illuminated Taxi Sign having dimensions 13.78 inches X 3.94 inches X 3.74 inches (LXBXH) respectively.

b. colour of hood of all metered autorickshaw shall be painted in cream yellow and rest of the body in black;

c. the permit number in addition to the registration mark, shall be painted on the cab in white in a red circle, the size of number being 5 centimeters in height and 4 centimeters in breadth at four different


