- weight) • Single-use, plastic bodied use & throw Pens.
- Plastic sheet/Pouches (transparent/coloured/layered) used for packaging of Water, Cooked Food, Gift items, etc. including bubble-wraps.

As per the A&N Administration vide Notification No.225 dated 24.09.2019, the use, manufacture and sale of plastic carry bags irrespective of its thickness, size, color and nature is also banned in A&N Islands. Similarly, selling as well as display/advertisement of Single Use Plastic (SUP) items on all E-Commerce website is also prohibited.


