Welfare's role as the State Adoption Resource Agency.

The Protection Officer, NIC, through a detailed power point presentation sensitized the participants on various aspects of adoption, including the mandatory registration of all types of adoption-Prospective Adoptive Parents (PAP), Relative Adoption, or Step-Parent Adoption-on the CARINGS Portal (www.carings.nic.in) of CARA. Participants were also informed about the options for family and group foster care.

The primary objective of the program was to raise awareness about the Adoption Regulations-2022 and promote legal adoption, discouraging direct, unregulated adoptions. Discussions also covered the procedure for surrendering children for adoption, ensuring their eventual placement in suitable families.

The program concluded with an interactive session, where participants raised their queries and shared their field experiences.
