Prime Minister's Internship Scheme aims to provide 1.25 lakh internships in FY 2024-25

New Delhi, Oct.5

The Government launched the pilot phase of the ambitious Prime Minister's Internship Scheme, which aims to provide 1.25 lakh internship opportunities during the fiscal year 2024-25 on Thursday. The scheme will involve the participation of the top 500 companies in India. First announced in the Budget 2024-25, the scheme envisions creating one crore internship opportunities for young people in top companies over the next five years. The initiative will be managed through an online portal developed by the Ministry of Corporate Affairs (MCA), accessible at www.pminternship.mca.gov.in.

Registration for the internships will be open from October 12 to October 25, 2024, and selected candidates will be notified between October 27 and November 7, 2024. Internship offers will be sent out by companies

between November 8 and November 15, with the first batch of internships set to commence on December 2, 2024.

The companies participating in the scheme were selected based on their average Corporate Social Responsibility (CSR) expenditure over the last three years, and their

involvement in the scheme is voluntary. Additionally, other companies, banks, and financial institutions can apply to participate with MCA approval. In cases where partner companies cannot offer internships in-house, they are allowed to collaborate with suppliers, customers, or other entities in their

value chain.

The internships, which will last for 12 months, will focus on real-world job environments, with at least half of the internship period dedicated to hands-on work experience. Interns will receive a monthly stipend of Rs. 5,000, with Rs. 4,500 provided by the

Government and Rs. 500 contributed by the company from its CSR funds. A one-time grant of Rs. 6,000 for incidental expenses will also be provided by MCA when interns join their workplace.

Interns will be insured under Government schemes like PM Jeevan Jyoti Bima Yojana and PM Suraksha Bima Yojana, with the Government covering the premium costs. Partner companies may offer additional accidental insurance coverage if desired.

Youth between the ages of 21 and 24 are eligible to apply, provided they are Indian

DRDO successfully flight-tests 4th Generation Very Short Range Air Defence System

New Delhi, Oct. 5 (PIB)

Defence Research and Development Organisation (DRDO) successfully conducted three flight-tests of the 4th Generation, technically-advanced miniaturised Very Short Range Air Defence System (VSHORADS) at the Pokhran Field Firing Ranges in Rajasthan on October 03 & 04, 2024. The tests were carried out against high speed target, demonstrating very critical parameters of maximum range and maximum altitude interception. These development trials s h o w c a s e d repeatability of hit-to-kill capability of the weapon system in various target engagement scenarios covering approaching,



receding and crossing modes.

The development of VSHORADS missiles has been completed and two production agencies have been engaged in the Development cum Production Partner (DcPP) mode. In these trials, the missiles realised through DcPPs have been successfully used, thus paving the way for early User trials and Production in a short time span in line with Prime Minister,

Shri Narendra Modi-led Government's vision of 'Aatmanirbhar Bharat'.

VSHORADS is a Man Portable Air Defence System designed and developed indigenously by Research Centre Imarat (RCI) in collaboration with other DRDO laboratories and DcPPs. The three Services have been associated with the project right from the beginning and participated during the developmental trials.

The scheme is open to candidates who have completed their high school or hold degrees such as BA, B.Sc, B.Com, BCA, BBA, B.Pharma, and various diplomas. However, graduates from top institutions like IITs, IIMs, and those holding higher qualifications like MBA, CA, CMA, and MBBS are ineligible.

One accused convicted for commission of POCSO Offence by Hon'ble Special Judge

The Hon'ble Special Judge Shri Niyaz Alam on 26th September, 2024 convicted one accused person, resident of Bimblitan Village, South Andaman in a sexual assault case committed by him against his minor daughter then aged about 12 years. It is averred that on 15.06.2022 when victim girl's mother had gone out for work, the accused locked the room and committed sexual assault upon his daughter. Meanwhile his sons who were playing outside came

back and knocked the room and being frightened with the knocking, the accused left the daughter and she apprised about the incident to her brothers and mother. Then the matter was brought to the notice of PS Pahargaon who registered case against the accused person under Section 376 of Indian Penal Code (IPC) read with Section 3(b)/5(1)(n)/9(n) of POCSO Act. The investigation was taken up by IO Seema Bhomick. The prosecution examined 14 witnesses and the

Hon'ble Court after conducting trial found the accused person guilty of the offence and sentenced him to suffer 03 years rigorous imprisonment under Section 7/8 of POCSO Act and ordered him to pay a fine of Rs. 10,000/- in default of payment of such fine further rigorous imprisonment of 03 Months. The case was conducted for and on behalf of the State by Special Public Prosecutor, Miss. A.S Zinu, a press release from Special Public Prosecutor (POCSO), A&N Islands said.




