

Empowering people with Disabilities through Unique Disability Identity (UDID) Card generation for Persons with Disabilities

Ministry generates 5075 UDID Cards and Disability Certificate for A&N Islands

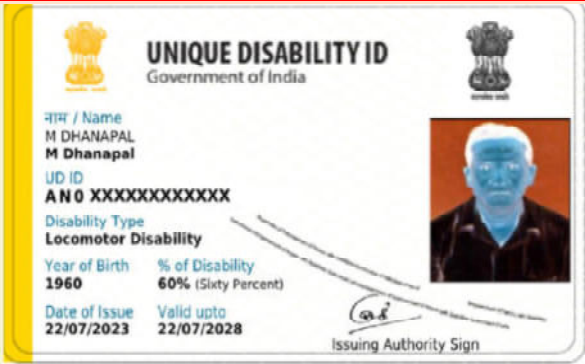

The Social Welfare Department, A&N Administration is implementing the Govt. of India scheme of Unique ID for Persons with Disabilities in an effective manner to empower people with Disabilities. The Aadhaar-linked Unique Disability Identity (UDID) Card would ensure their ease to access various Government schemes & benefits. The Ministry of Social Justice and Empowerment, Govt. of India had launched this project in the year 2016 with a view to create a National

Database for PwDs and to issue a Unique Disability Identity Card to each person with disabilities.

The Ministry has so far generated 5075 UDID cards and Disability Certificate for A&N Islands and the coverage rate has also increased benefitting the Persons with Disabilities in all the three Districts (South Andaman, N&M Andaman and Nicobars). A&N Islands stands 3rd in India in implementing the GoI scheme of Unique Disability Identity (UDID) Card generation.

The Unique Disability ID (UDID)



Smart Card contains details such as disability percentage, identity of a person with disability. With UDID Card, the Persons with Disabilities are eligible for free aids and appliances, they will get priority in medical treatment, priority at ticket counters, priorities in hearing of their grievances, free bus passes and

scholarship for students etc.

The project has not only brought transparency, efficiency and ease of delivering the Government benefits to the person with disabilities, but also ensured uniformity. It has helped in streamlining the tracking of beneficiary at all levels of hierarchy of implementation - at

village, block, District, State and National level.

The Departments of Health and Social Welfare are coordinating to help the disabled get disability certificate and UDID card from the notified Medical Authorities. A person with multiple disabilities is assessed by a Medical Board comprising of specialists to assess the percentage of disability and issue the Disability Certificate after which it is uploaded on the National portal:

However, it has been noticed that in spite of repeated request and all possible effort, there are considerable number of (APL, AAY & PHH) beneficiaries who have not yet approached their Fair Price Shops or the Department of CS&CA or respective Supply Units functioning in the inter Islands for updating their e-KYC. Hence, all those left out Ration Card

beneficiaries (APL, AAY & PHH) who have not yet updated their e-KYC due to whatsoever reason have once again been requested to contact any of their nearest Fair Price Shop along with their Aadhaar numbers to get e-KYC done latest by 31.10.2024 for all the members listed in the Ration Card, failing which, such members of the Ration Card shall be considered bogus and action shall be taken as per the relevant rules.

One person arrested for alleged matrimonial fraud

Police urges citizens to remain vigilant and exercise caution when forming relationships online

In a distressing case of matrimonial fraud, S.C. Ali Harman has been arrested following allegations that he deceived a local woman for money. The complaint, lodged at PS Aberdeen, outlines a series of deceitful interactions that began on the Muzz

App, a popular matrimony platform for individuals from Muslim communities. According to the complainant, the accused befriended her on the app and lured her into a relationship with promises of marriage. The situation escalated during a visit to Sri Vijaya Puram, when he

reportedly convinced her family to give him money, citing vague reasons for the urgent need for funds and managed to deceitfully receive an amount of around 3 lakhs Rupees. After leaving the Andaman Islands, Harman allegedly blocked both the complainant and her family on all

37th National under 11 Chess Championship 2024 concludes; Isles players show impressive performance

The 37th National Under-11 Boys and Girls Chess Championship - 2024 concluded on Oct. 11, wrapping up an exciting seven-day competition that witnessed a total of 11 intense rounds of chess. The championship, hosted at Hyderabad under the auspices of the All-India Chess Federation, saw the participation of 456 boys (including 308 rated players) and 200 girls (with 105 rated players) from across India.

Players from the Andaman & Nicobar Islands delivered remarkable performances, showcasing their skills against strong competition. Among the standout performers from the Andaman & Nicobar Islands was J.S. Virat, the top scorer from Andaman in the Open Category with an impressive 6 points, securing three wins and two draws against higher-rated opponents, which resulted in a significant increase of 61 Elo points in his international rating. Following him, AFM Shrihaan Karmakar demonstrated strong resilience with 4.5 points, achieving one win and one draw against rated players. Y. Rushil also made his mark with 4.5 points, notching two victories against rated opponents, enhancing his chances of opening his FIDE rating. A. Sharad held his ground with 4.5 points, showcasing his defensive prowess by securing a draw against a higher-rated player. R. Siddharth played reasonably well, finishing with 4 points, including a notable win against a rated player. In the Girls Category, Parnita and Krishnapriya B. Rajesh both scored 4 points, ANCA said.

Players from the Andaman & Nicobar Islands delivered impressive performances, strengthening their presence in national chess. The 37th National Under-11 Chess Championship served as a crucial platform for young talents, nurturing their ambition for future national and international success, a press release from ANCA said.
