Aves is a small and beautiful Island, also known as Coconut Island for its lush green coconut plantation. Presently. Aves is not open for tourists. It is an uninhabited island with no accommodation facilities, but with the proposed five-star eco-tourism resort, Aves will be the most sought-after tourist destination after Swaraj Dweep in Andaman, the officer said.

With an investment of nearly Rs 36 crore, the fivestar eco-tourism resort (2.75 hectare) at Aves Island will have 50 rooms where the concessionaire can undertake various activities like a shopping area for local souvenirs, scuba diving, game fishing, forest trekking, nature camping, wellness centre, etc.




