



METHOD OF RECRUITMENT, AGE LIMIT AND **QUALIFICATIONS: -**

The method of recruitment to the post, age limit, qualifications and other matters relating thereto shall be as specified in SI. No. 5 to 13 of the said Schedule.

4. DISQUALIFICATION:

No person -

 a) Who has entered info or contracted a marriage with a person, having a spouse living, or

b) Who, having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lieutenant Governor, Andaman and Nicobar Islands, if satisfied, that such marriage is permissible under the personal law applicable to such person and other party to the marriage and there are other grounds for doing, exempt any person from the operation of this rule.

5. POWER TO RELAX: -

Where the Lieutenant Governor (Administrator), Andaman and Nicobar Islands is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of posts or persons.

6. SAVING:

Nothing in these rules shall affect the reservations and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
