

Free Health Coverage for All Seniors 70+

In a landmark decision, the Union Cabinet approved an expansion of the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB PM-JAY) on September 11, 2024, offering comprehensive health insurance to senior citizens aged 70 and above. This move will provide free health coverage of up to Rs. 5 lakh per family, regardless of income, benefiting around 6 crore senior citizens across 4.5 crore families.

Under this expansion, all senior citizens in this age group will receive a new distinct card under AB PM-JAY to access the scheme's benefits. For senior citizens aged 70 and above who already belong to families covered by AB PM-JAY, an additional top-up cover of Rs. 5 lakh per year will be provided exclusively for their use, separate from the rest of the family. Those who are not part of the existing scheme will receive Rs. 5 lakh of annual coverage on a family basis.

(cumulative) have become successful entrepreneurs. A total number of 2627 male and 4222 female candidates were trained in different EDP training programmes since inception of the RSETI in these Islands. RSETI programme which is a three-way partnership between the Rural Development Ministry, State Governments and sponsor banks, the Entrepreneurship Development Programmes are organized in different sectors i.e. Agriculture, product, process and general EDPs.

Under Agriculture, EDP trainings are imparted for vegetable nursery management & cultivation, poultry. Under product, EDP trainings are imparted for women tailoring and papad, pickle & masala powder making. Similarly, in the process, EDP training are imparted in beauty parlour management and Fast Food Stall Udyami and under general EDP, the training are imparted for soft skill to the trainees mostly of Directorate of Industries. The duration of training ranges from 10 days to 30 days. The trainings are free of cost and the trainees are provided with free lunch, tea & materials required for training. The training includes interaction sessions, games, motivational videos; communication skills, market survey etc which are required for a successful entrepreneur.

RSETI in collaboration with the Rural Development Department was able to reach out to the remote Islands and was able to train SHG members in Rangat, Mayabunder, Diglipur in off campus trainings since 2020. RSETI regularly conducts awareness camps at the remote villages to sensitize the rural youth about the importance of being self employed.




