

Objections and suggestions are invited form the stake holders/ persons to be affected thereby. The objections and suggestions (if any) should reach the Office of the Directorate of RD and Panchayats within 30 days from the date of its publication in the official website for consideration.

### 1. Short title and commencement

- i. These rules may be called the Andaman and Nicobar Administration (Group B post of Block Development Officer) Recruitment Rules, 2023.
- ii. They shall come into force on the date of their publication in the Official Gazette.

### 2. No. of posts, classification and scale of pay.

The number of posts, their classification and scale of pay attached thereto, shall be as specified in paras 2 to 4 of the Schedule annexed

### 3. Method of recruitment, age limit, qualification:

The method of recruitment to the post, age limit, qualifications and other matters relating thereto shall be as specified in paras 5 to 14 of the said Schedule.

### 4. Disqualification: -

No person-

i. Who has entered into or contracted a manage with a person having a spouse living:

ii. Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post

Provided that the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, if satisfied that such marriage is permissible under the personal law applicable to such persons, and other party to the marriage and that there are other grounds for doing, exempt any person from the operation of this rule.

### 5. Power to relax

Where the Lieutenant Governor (Administrator), Andaman and Nicobar Islands is of the opinion that it is necessary or expedient to do so, it may by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of posts or persons.

### 6. Savings

Nothing in these rules shall affect reservations, and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.






