The Andaman & Nicobar Islands with pristine clear waters, sandy beaches, abundant coral life and convenient geographical location makes an ideal destination for International Sailors. In recent years, International Yachts have shown keen interest in visiting Andaman and Nicobar Island Ports to enjoy the beauty of these emerald Islands. The numbers of foreign yachts have considerably increased manifolds touching up to a maximum of 64 numbers of Yachts per year. #### A. Conditions of Eligibility

- 1. Candidates who possess Graduation and Diploma Certificate in the designated subject field i.e. Mechanical Engineering, Electrical Engineering and Electronics and Communications Engineering are eligible for the proposed Apprenticeship Training.
- 2. The Candidates who have already been trained in this Directorate or any other Department under this scheme or having job experience for a period of one year or more is not eligible, in terms of prescribed
- 3. The candidates who have already undergone Apprenticeship under this Act/ Govt. of India's scheme and in whose case the contract of Apprenticeship was terminate for any reason whatsoever shall not be eligible.

#### B. Period of Training

1. The Apprenticeship Training will be for a period of one year as per the order issued by this Directorate. 2. During the Apprenticeship Training period the trainee may be attached to any Shop of Marine Dockyard, DSS and will be under the Administrative Control of the Director (Shipping Services), A&N Administration, Sri Vijaya Puram.

#### B. Rate of stipend payable per month.

An amount of Rs. 8000/- (Rupees eight thousand only) for Diploma holder and a sum of Rs. 9000/-(Rupees nine thousand only) for Degree holder will be paid per month as stipend for per trainee. C. How to Apply:


