e-Shram registered workers or nominees urged to file claims for accidental risk coverage

Timeline for submission of claim settlement under e-Shram portal extended till June 30

Sri Vijaya Puram, June 15

The Ministry of Labour & Employment launched the e-Shram portal on 26<sup>th</sup> August, 2021 for the creation of a comprehensive National Database of Unorganized Workers (NDUW), seeded with Aadhaar. At the time of the launch, the Ministry had also announced accidental risk coverage (in case of accidental death or partial/permanent disability) for all e-Shram registrants for the first year.

Accordingly, the Ministry developed an e-Shram Ex-Gratia Module to facilitate the submission and settlement of claims by eligible registrants

through an ex-gratia mechanism. As per the provisions of the module, District Magistrates are designated as the approving authority for such claims.

The Ministry has now extended the timeline for submission of claim settlement under e-Shram portal till 30<sup>th</sup> June, 2025.

All concerned individuals who are registered on the e-Shram portal or their nominees, who have suffered an accidental death or partial/permanent disability on or before 31<sup>st</sup> March, 2022 and have not yet submitted their claims have been requested to approach the Facilitation Centre, O/o ANBOCW Welfare Board, Labour Department, Supply Line, Sri Vijaya Puram (Phone No: 8900901130) along with requisite documents to file their claims through the designated portal.

All stakeholders have been advised to avail themselves of this opportunity before the expiry of the extended time limit, a press release from Office of the Labour Commissioner & DET said.

Registration of PIBOs/PWPs/ Sellers/Manufactures in centralized EPR portal for plastic packaging

Sri Vijaya Puram, June 15

Extended Producer Responsibility (EPR) under the Plastic Waste Management Rules mandates Producers, Importers, and Brand Owners- including manufacturers of compostable / biodegradable plastics- to ensure proper processing of their plastic packaging

waste through recycling, reuse, or environmentally sound disposal methods (e.g., co-processing, waste-to-energy, plastic-to-oil, road making, industrial composting).

To streamline EPR implementation, the Ministry of Environment, Forest and Climate Change (MoEF&CC), through the 4<sup>th</sup> Amendment to the Plastic Waste Management Rules dated February 16, 2022, introduced 'Guidelines on Extended Producer Responsibility for Plastic Packaging' (Schedule II).

Accordingly, a Centralized EPR Portal has been developed for registration of Producers, Importers,

DLSA to hold National Lok Adalat on June 21

The District Legal Services Authority, Andaman & Nicobar Islands will be holding National Lok Adalat in the District Court Complex at Port Blair and Sub-Divisional Court Complex at Mayabunder and Circuit Court at Diglipur on 21.06.2025. Besides the compoundable nature of cases pending in different Courts, disputes at the pre-litigation stage will

also be entertained by the National Lok Adalat for disposal upon consensual settlement between the parties. Pre-litigation disputes include (i) NI Act cases u/s 138, (ii) Money recovery cases, (iii) Labour dispute cases, (iv) Electricity and water bill cases (excluding non-compoundable), (v) Maintenance cases (vi) Civil disputes and (vii) Disputes under the Consumer Protection Act.

The public in general having any such dispute at the pre-litigation stage or post-litigation stage are at liberty to submit their disputes in writing to the Secretary, District Legal Services Authority, Port Blair before June 16, 2025, so that their disputes may be processed and made ready for hearing before the National Lok Adalat on June 21, 2025, a press release from DLSA said.

Isles players shine at 21<sup>st</sup> Delhi International Open Chess Tournament 2025

Sri Vijaya Puram, June 15

The prestigious 21<sup>st</sup> Delhi International Open Chess Tournament 2025 concluded yesterday evening at Tivoli Gardens, New Delhi, with over 2,500 players from around 20 countries competing across multiple rating categories. The event witnessed intense competition and was one of the largest open chess tournaments in Asia this year.

Around 15 young players from the A&N Islands took part in this prestigious event and made a strong impression with notable performances in both the Category A and C events. In the Category C event (for players rated



below 1700), Shrestha Vijay D, a young and promising talent from the Islands, showcased his skills and secured 2<sup>nd</sup> position in the 'Best Player from North East & Andaman' category, earning a cash prize of Rs.15,000.

Meanwhile, in the elite Category A (Grandmaster section), R. Kashthuri Bhai, a rising chess prodigy from the Islands, delivered an exceptional performance, gaining over 50 Elo rating points and crossing a live FIDE rating of 2000. With this, she has become eligible for the Woman Candidate Master (WCM) title, which she is set to receive officially next month. This over-the-board title marks a historic moment, as she becomes the first female player from Andaman & Nicobar Islands to cross 2000 live rating, and the first-ever from the territory to achieve a FIDE Player title, a press release from ANCA said.

and Brand Owners (PIBOs) operating in more than two States with the CPCB. Those operating in one or two States/UTs must register with the respective State Pollution Control Boards (SPCBs)/ Pollution Control Committee. Plastic Waste Processors (PWPs) must also register on this portal as per Section 13(3) of the Plastic Waste Management Rules, 2016.

As per the latest amendment dated March 14, 2024, the entities who must register on the EPR portal for plastic packaging are manufacturers of plastic raw materials, importers of plastic raw materials, micro & small producers and sellers of plastic raw materials.

All the producers including micro and small categories, importers, brand owners, manufactures/importers/sellers of plastic materials in A&N Islands should register themselves on the centralized EPR Portal developed by the Central Pollution Control Board (CPCB). Action, as deemed fit under Environment Protection Act, 1986 including levying of Environmental Compensation as per the Guidelines shall be taken against the defaulter.

Definitions as per Plastic Waste Management Rules, 2016 (as amended) and Link of EPR portal are as under-

◆ **Producer:** A person engaged in manufacturing plastic packaging, including manufacturing intermediate materials for plastic packaging, and those engaged in contract manufacturing of products using plastic packaging for brand owners.

◆ **Manufacturer:** A person involved in the production of plastic raw materials, including compostable and biodegradable plastics.

◆ **Seller:** A person who sells plastic raw materials such as resins, pellets, or intermediate materials used in producing plastic packaging.

◆ **Importer:** A person who imports, for commercial use, any plastic packaging, commodity with plastic packaging, carry bags, plastic sheets, plastic raw materials (resins or pellets), or intermediate materials for manufacturing plastic packaging.

◆ **Brand Owner:** A person or company selling any commodity under a registered brand label or trademark.

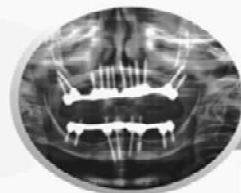

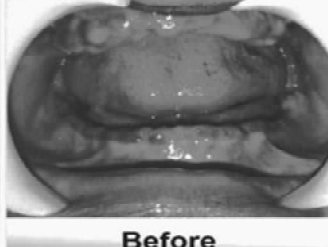

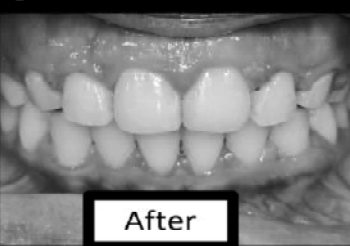
