- Revival of Japanese wells along the lines of those in Car Nicobar.
- Efficient method of desalination.
- Action plan of water management in Islands to prevent the saline water intrusion.
- Augmenting existing water infrastructure with latest rainwater harvesting technologies.

The SEOC and DEOC informed all resource Department for deployment of their teams to SVP MC to manage the disaster

ORDER

WHEREAS, an information received from Superintendent of Police (CID), A&N Police regarding the planned dharna/protest (Raj Niwas Gherao) by the PRIs of North and Middle Andaman to be held in front of Raj Niwas on 06.03.25 under the leadership of Shri Bishnu Pada Ray, Hon'ble Member of Parliament and supported by the PRIs members of South Andaman. The unlawful gathering of these people can cause breach of peace and disturbance of public tranquility, and pose risks to human life, safety, and public property, hence it is necessary that immediate action is taken for the prevention of the same.

Now therefore, I, Arjun Sharma, IAS, District Magistrate, South Andaman District is of the opinion that it is necessary to take suitable measure to stop the unlawful gathering.

Now, therefore, I, Arjun Sharma, IAS, District Magistrate, South Andaman District in exercise of the powers conferred upon me by virtue of section 163 of Bharatiya Nagarik Suraksha Sanhita (BNSS)-2023, do hereby prohibit assembly of five or more persons at and around Raj Niwas, RGT Road, Kamraj Road and Secretariat on 06.03.2025 and shall remain into force till further order. Any breach of this order would invite action Under Section 208 of Bharatiya Nagarik Suraksha Sanhita (BNSS)-2023.

This order shall not apply to the Executive Magistrate, police personnel and other public servants on duty.

In view of the emergent situation this order is passed ex-parte and addressed to the general public.

This order shall be enforced by the Sub Divisional Magistrate, South Andaman, Superintendent of Police, South Andaman and Executive Magistrate during the above period.

This order shall be promulgated by affixing copy thereof at the notice board of the office of the undersigned as well as the District Court, Port Blair and publication in Newspaper having circulation in the areas through office of the Information & Publicity, A&N Administration.

PS Billiground seizes 10.493 kg of ganja; one arrested

In a swift and well coordinated operation, on March 2, 2025 PS Billiground successfully intercepted a major illegal drug transaction, seizing a substantial quantity of ganja and arrested the accused.

Under the leadership of Shri Chandan G.S., SDPO Rangat, a specialized team was swiftly constituted to act on intelligence regarding an illegal drug transaction. Rs. 19,800 per kW for capacities between 2 kW and 3 kW. In addition, the UT Administration shall provide additional subsidy of Rs. 45,000 per kW for up to 2 kW capacity and Rs. 27,000 per kW for capacities between 2 kW and 3 kW. The application process has been simplified through the PM Surya Ghar portal, and a collateral-free loan option is available through nationalized banks.

The Surya Rath will travel across various locations to create public awareness about the scheme, offering on-the-spot registrations for interested consumers. Once rooftop solar plants are installed, the CFA and UT subsidies will be directly credited to the consumers' bank accounts. Additionally, consumers who become prosumers (installing RTS plants) producing and consuming electricity will benefit from a separate solar tariff under regulatory approval further reducing electricity charges. The ultimate goal of this initiative is to achieve 100% solarization of households, thereby promoting energy security, sustainability, and enhanced solar power adoption, a press release from Electricity Department said.
