PM inaugurates 4th Global Renewable Energy Investor's Meet and Expo (RE-INVEST) in Gandhinagar

India is the first nation in the G-20 to achieve the climate commitments set in Paris, 9 years ahead of the deadline: PM

New Delhi, Sept. 16 (PIB)

The Prime Minister, Shri Narendra Modi inaugurated the 4th Global Renewable Energy Investor's Meet and Expo (RE-INVEST) at Mahatma Mandir, Gandhinagar in Gujarat today. The 3-day summit honours the important contributors to India's remarkable achievement of over 200 GW of installed non-fossil fuel capacity. Shri Modi also took a walkthrough of the exhibition showcasing cutting-edge innovations from public and private sector companies, start-ups, and major industry players.

Addressing the gathering, the Prime Minister welcomed all the dignitaries to the 4th edition of the RE-INVEST Summit and expressed confidence that serious discussions will take place over the next three days on the future of energy, technology and policies. Shri Modi said that the discussions and learnings from this conference will benefit the entire humanity. He conveyed his best wishes for successful discussions.

The Prime Minister underscored the mandate of the people of India to elect the same Government for a record third time after sixty years. "Aspirations of India is the reason behind the reelection of the Government for the third term", Shri Modi remarked. He highlighted the trust and confidence of the 140 crore citizens, the youth and women who believe that their aspirations will take new flight in this third term. The Prime



Minister underlined that the deprived believe that the poor, dalits and the Government's third term will

become a guarantee for a dignified life. He said that 140 crore citizens of India are working with the resolve of making India the third-largest economy in the world. Noting that today's event is not an isolated one but a part of the bigger vision, mission and action plan to make India a developed nation by 2047, the Prime Minister highlighted the decisions taken by the Government in the first 100 days in office.

"Government's work in the first 100 days highlights its priorities and gives a reflection of the speed and scale", PM Modi remarked underlining that all sectors necessary for India's fast-paced development have been emphasized. In these 100 days, the Prime Minister said that multiple decisions have been taken to expand the physical and social infrastructure of the nation. During the meeting, Shri Ray highlighted the issue of farmers of the Islands pertaining to supply of Urea and DAP and urged for supplying the same at subsidized rate to farmers. He also mentioned about importance of developing/providing alternatives as organic fertilizers suitable for the Islands through KVK/CIARI for making the Islands as Organic Islands. He also



highlighted about Mealybug infestation in plantation crops.

The MP further enlightened about the need for filling up vacant posts in District Hospital, Mayabunder and ultrasound facilities in North & Middle Andaman, CHC, District Hospitals to facilitate pregnant women. He also spoke about the need for proper maintenance of roads in Municipal areas, as well as rural roads under Panchayat/Samiti and Zilla Parishad. He highlighted the need for

allocating 25% of the total budget to PRI/ PBMC. Various other issues pertaining to the Islands were also raised by the MP during the meeting, a press release from MP Office said.

crore houses which is more than the population of many countries, while 4 crore houses have been handed out to the people in the last two terms. He further stated the decision to create 12 new industrial cities, approval for 8 high-speed road corridor projects, launching of more than 15 semi-high speed Vande Bharat trains, the inception of a research fund worth Rs 1 trillion to promote research, the announcement of various initiatives to drive e-mobility, promotion of high-performance biomanufacturing and approval to Bio E3 policy.

Throwing light on the developments in the green energy sector in the last 100 days, the Prime Minister mentioned the initiation of a viability gap funding scheme for offshore wind energy projects worth more than Rs 7000 crore. He said that India is working towards producing 31,000 megawatts of hydropower in the coming times with an outlay of Rs 12,000 crore.

The Prime Minister said that India's diversity, scale, capacity, potential and performance are all unique and pave the way for Indian solutions for global applications. "Not just India, the whole world is of the belief that India is the best bet of the 21st century", exclaimed the Prime Minister. Recounting the global events hosted by India in the last one month, Shri Modi said that Global Fintech Fest was organized earlier in this month, people from across the globe participated in the First International Solar Festival, Global Semiconductor Summit, India also hosted the 2nd Asia-Pacific Civil Aviation Ministerial Conference and today India is hosting a conference of Green Energy.

Shri Modi remarked that it was a happy coincidence that Gujarat which has witnessed the inception of White revolution, Sweet (Honey) revolution, Solar revolution is now seeing the organization of 4th Global Renewable Energy Investor's Meet and Expo. "Gujarat was the first state in India to have its own Solar Policy", highlighted the Prime Minister. He added that National policies on solar followed after this. Shri Modi further highlighted that Gujarat was one of the front runners across the world in setting up a Ministry pertaining to matters of climate. He highlighted that Gujarat had already started setting up Solar plants when the world had not even thought of it.

Pointing to the name of the venue - Mahatma Mandir, Shri Modi remarked that it was named after Mahatma Gandhi, the pioneer who alerted the world when the topic of climate challenge had not even emerged. Quoting Mahatma, the PM said - "Earth has enough resources to fulfill our needs, but not to satisfy our greed." He added that this vision of Mahatma Gandhi has emerged from the great tradition of India. Shri Modi remarked that words like Green Future, Net Zero were not fancy words but are the needs & commitments of the Union and every state Government of India.

The Prime Minister said India is the first G20 nation to achieve the climate commitments set in Paris, that too 9 years before the deadline. Shri Modi outlined the nation's goals to achieve the target of 500 GW of renewable energy by 2030 and said that the Government has turned the green transition into a people's movement. He suggested studying India's unique scheme for Rooftop Solar - PM Surya Ghar Free Electricity Scheme where the Government funds a Rooftop Solar Setup for every family and helps in installation. Through this scheme, the Prime Minister said, every household in India becomes a power producer. He informed that more than 1 crore 30 lakh families have registered under the scheme and installation work has been completed in 3.25 lakh houses so far.

PS Rangat seizes 3.09 kg of drug ; two persons arrested

Rangat, Sept. 16

In an on-going operation against the drug menace, and based on information provided by Sanjeev Kumar Halder, during his police custody following his arrest under the NDPS Act by PS Rangat, it was revealed that Sanjeev Halder had been supplied with Methamphetamine by Ashok Maithy, a retired Electrician from MES, resident of Buniyadabad, and Raju Golder, a private worker, resident of Hutbay.

On Sept.16, 2024, based on an input, it was discovered that the suspects are traveling to Diglipur by bus to sell the drugs. Acting on this, SDPO Rangat immediately formed a raiding team led by SI Madhab Halder, SHO PS Rangat. The team intercepted the bus in which Ashok Maithy and Raju Golder were traveling near Rangat and conducted a search of their bags. A search of Raju Golder's bag resulted in the recovery of 3.09 kg of Methamphetamine. During the preliminary

inquiry, the main accused, Raju Golder, revealed that he had obtained the drugs from floating parcels at sea. Upon further interrogation, both suspects confessed to their involvement. The investigation confirmed their involvement to the NDPS case registered against Sanjeev Kumar Halder on 02/09/2024 at PS Rangat.

Subsequently, on Sept.16, 2024, Ashok Maithy, 61 years, S/o Ram Krishna Maithy, R/o Buniyadabad, Retd. MES Electrician and Raju Golder, 36 years, S/o Anadhi Golder, Private Worker, R/o Hutbay, were arrested for committing offence under the NDPS Act, at PS Rangat. The investigation is in progress.

The whole operation was conducted under the supervision of Shri Rahul L. Nair, IPS, SDPO, Rangat and overall direction and supervision of Ms. Geetanjali Khandelwal, IPS, Superintendent of Police, North & Middle Andaman District, a press release from SP, N&MA said.

Customized five -day training programme for Engineers of APWD by CSIR- CRRI commences

A customized five-day training programme has commenced for the Engineers of APWD by CSIR- CRRI in the Training Hall of CE's Office Complex. The training was inaugurated by Dr. Manoranjan Parida, Director, CRRI in the presence of Er. T.K. Prijith Rekha, Chief Engineer, APWD. While inaugurating the training, the Director, CRRI informed that the training is tailor made to suit the need of the Engineers of APWD. The training will also cover use of locally available materials, quality check of road construction materials, design of flexible pavement and structural evaluation of flexible pavement.

Keeping in mind the weather condition of A&N Islands and the willingness of the Administration to introduce white topping/ rigid pavement, it was also decided to include design of cement concrete pavements, design of white



toppings, project planning & DPR preparation. The training will also cover utilization of different industrial wastes/ marginal materials including Municipal Solid Waste for sustainable road construction with case studies. The ground improvement techniques, soil stabilization and geo-synthetic material in road construction is also included in the training programme.

While welcoming the chief guest, trainers and other participants, the Chief Engineer, APWD requested all the participants to make maximum use of the training and to implement at site for improvement of the quality of the road construction. He further

informed that the initiation of training was as per the direction of the Chief Secretary. Accordingly, the A&N Administration has approved the proposal of APWD to impart the training through CRRI. The newly appointed Engineers of APWD were asked to take maximum benefit of the programme. The training is also being imparted to Engineers, especially in the Southern Group as well as North & Middle through video conferencing.

Vital importance of Ozone Layer protection & minimizing adverse impact on climate change highlighted

The World Ozone Day is generally observed globally on Sept.16, every year across the world. In this connection, a programme was organized today in the premises of Silva Complex, Haddo, Sri Vijaya Puram with the theme 'Montreal Protocol: Advancing Climate Action', to create awareness among Ministerial, Executive as well as Industrial Staff and to educate the students of Govt. Senior Secondary School (Tamil Medium), Haddo about the vital importance of ozone layer conservation. Around 30 students along with 2 Teachers participated in the programme.

Shri Birendra Choudhary, IFS, Deputy Conservator of Forests, Silviculture Division, Haddo emphasized the vital importance of Ozone Layer protection and minimizing the adverse impact on climate change and focused on the awareness on Ozone layer depletion.
