Digital India Internship Scheme by MeitY-2024

Interested and eligible students may apply online by May 21

Port Blair, May 18

The Ministry of Electronics and Information Technology (MeitY) has launched the Internship Scheme 2024 having 24 seats in various areas. The duration of internship shall be of two months, extendable up to three months, depending on the performance of the candidate, requirement of the Ministry and the time the intern is willing to spend with the Ministry. The internship will start from 3rd June, 2024. The online site is open since May 6, 2024 and the last date for

applying is May 21, 2024.

For the larger benefit of the student community and with a view to enrich the management/ implementation of its various schemes/ programmes, MeitY has decided to notify "Internship Guidelines", to provide a framework for engagement of Interns for a limited period.

As per the eligibility criteria, Indian students from recognized universities in India who have secured at least 60% marks in the last held degree or certificate

examination and pursuing B.E/B.Tech/ M.E/ M.Tech (Computer Science & Engineering (CSE)/ Computer Science (CS)/IT/Electronics & Communications (EC) / Electronics/ Electrical), M.Sc. (CS/ IT/ Electronics/ Electrical), MCA/ DOEACC 'B' level, LL.B , B.E/B.Tech (Electronics & Communications (EC)/ Electronics) and MBA (Finance) or M.Sc.(Electronics) and MBA (Finance) are eligible for internship. LL.B students would be considered for internship only for

District Magistrate, South Andaman issues Order under Section 144 for compulsory tenant verification Order under Section 144 issued in the interest of overall safety and security of the Islanders

Port Blair, May 18

Keeping in view the increase in crime rate in the Islands and the apprehension that anti-social elements may make their hideouts clandestinely in the residential/ commercial areas of the South Andaman District and also to check the unlawful activities of these people who can cause breach of peace and disturbance of public tranquillity besides posing grave danger to human life and safety and injury to public property, the

District Magistrate, South Andaman had issued Order U/s 144 of the Cr. P. C as an emergency measure.

To keep some check/vigil over such unscrupulous elements, it is necessary on landlords/owners/ managers of the residential/ commercial establishments that while renting out or sub-letting the premises shall rent out or sub-let a n y accommodation to any person, he/she has to furnish the particulars of the said tenants or

the local Police Station.

Also no landlord/owner/ tenant/manager or the residential, commercial etc establishments shall employ any servant/house help, unless and until he/she has furnished the particulars of the said servant(s) to the local Police Station. All the persons who intend to offer accommodation on rent or employ any servant/house help shall inform in writing the particulars of tenants, paying Guests & Servants to the Station Administration,

Officers concerned in whose jurisdiction the premises fall. Any breach of this order would invite action Under Section 188 of the Indian Penal Code.

The order has come into force with effect from zero hours on 18/05/2024 and shall be effective for a period of sixty days and is applicable to those also who already have domestic servants/ maids and has not informed the Police yet when the order is in force.

This Order has been issued by the District

South Andaman so that anti-social elements in the guise of ordinary tenants, domestic servants & Paying Guest may not cause harm to the citizens and that immediate action is necessary for prevention of the same.

The Deputy Commissioner, South Andaman stated that very strict view will be taken, if anyone does not comply with the said 144 Cr. P. C. Order, a press release from Office of the District Magistrate, South Andaman said.

PS Bambooflat Police thwarts major drug operation; 3 peddlers arrested

Port Blair, May 18

Continuing its commitment in eradicating illegal drug trade and keeping the community safe, the Police Station Bambooflat under South Andaman seized 150 grams of illicit ganja and apprehended 3 persons. On May 17, 2024, credible information was received that an individual named Harbaz Ali was in possession of illicit ganja and intended to sell it at a lucrative price near the Fish Market, Bambooflat. Upon receipt of this information, a team comprising of Inspector Rizwan Hassan, SHO, PS Bambooflat, SI Manoj Lal, HC Zubair, PCs Shiva, Suresh Kumar, and Mubeena Banu was constituted. The team, augmented by two independent witnesses, proceeded to the location. Upon identifying the suspect, Harbaz Ali was intercepted, and during his personal



check, a plastic pouch containing 40 grams of illicit ganja was found. The recovered illicit ganja was seized on the spot and the accused was arrested under NDPS Act.

During interrogation, the accused revealed that he had purchased the illicit ganja from an individual named Abhinav, also known as Shan. Subsequently, the raiding team conducted raid at Abhinav's residence in Prothrapur and recovered 60 grams & 50 grams of illicit ganja from the possession of Abhinav Howlader and Ruban Raj respectively. The recovered illicit ganja was seized on the

spot after observing all codal formalities. A total of 150 grams of illicit ganja was seized during this operation, which was conducted under the direct supervision of DySP Vinay Mathur, SDPO Bambooflat and overall supervision of Smti Niharika Bhatt, IPS, SP District South Andaman.

Meanwhile, the general public have been requested to inform about any credible information pertaining to sale or possession of contrabands or any other illegal activity on telephone numbers- 100, 258411, 9434270033. The identity of the informer will be kept secret, a press release from SP (SA) said.

- Never share any compromising images, posts, videos of yourself to anyone, no matter who they are.
- Never pick up any calls / video calls from anonymous number.
- Turn off your electronic devices and web cameras when you are not using them.
- Use two factor authentication with strong passwords and different passwords for your different social media accounts.
- Enable privacy and security features in all your social media accounts.
- Do not suffer in silence, know that you are not alone, reach out and seek help from trusted family and friends.
- Avoid browsing the suspicious websites and websites which you are fully not aware.
- On social media or dating platforms, be cautious of unknown users who try to move the conversation to another interactive platform very quickly.
